THE UNDERSIGNED CLIENT HEREBY ENGAGES THE ABOVE MENTIONED DJ, FOR THE ENGAGEMENT DESCRIBED ABOVE AND THE DJ AGREES TO PERFORM UNDER THE DIRECT SUPERVISION AND CONTROL OF THE CLIENT.

The CLIENT shall supply:

- 1 A suitable premises – must have proper permits or authorization to use the venue.
- 2 A wide and clear performance area, minimum 8 feet by 8 feet.
- 3 A sturdy workplace or surface – standard hall tables in good condition will be good.
- 4 Dance Floor as available at the venue.

The CLIENT agrees:

- 1 To provide adequate security and health standards to protect the well-being of the DJ during the engagement.
- 2 No one except the DJ will be allowed to touch, manipulate, work or in any way handle the DJ's Equipment.
- 3 To be responsible for any injury to the DJ or damage to the DJ's equipment while on the premises of said engagement, if damage or injury is caused by the CLIENT, guests or any other person in attendance.
- 4 The performance will not be recorded, reproduced, or transmitted in part or whole from the place of performance.
- 5 Not to request the DJ to perform in a way that may invite illegalities. (ie. Sound Volume)
- 6 To provide suitable power outlets near the set up area. DJ cannot be held responsible for feedback due to bad wiring at the venue.

The DJ shall supply:

- 1 A suitable sound system for the venue.
- 2 Music in the form of CD or MP3.
- 3 Dance lighting, KARAOKE equipment, Screens if requested.

The DJ agrees:

- 1 To perform professionally, to the best of his skills and ability for the duration of the specified event.
- 2 To give adequate notice in the event of a cancellation due to circumstances beyond his control (ie. Sickness, accident, theft of equipment, acts of God) at which time the fee will be refunded to the client, not to exceed the contract amount.
- 3 To act and abide by the "house rules" of the CLIENT.
