### **Agritourism**

At the 2019 Governor's Conference, a new trend in tourism was identified -- visitors want experiences. This is particularly true for the millennials. Visitors no longer want to be passive and look at attractions. They want to be involved; they want to do something.

People have become more interested in how their food is produced. They want to meet farmers and processors and talk with them about what goes into food production.

This is agritourism, an important subset of the tourism industry. It's agriculture and tourism together whereby an agriculturally based operation or activity brings visitors to a farm or ranch.

Think about including an agritourism activity in your itinerary. Possibilities include learning about wine, beer or cheese making, buying produce direct from a farm stand, navigating a corn maze, touring

a carrot production facility, staying at a B&B or farm stay, or shopping in a farm gift shop for hand-crafted gifts.

In Colorado the Colorado Agritourism Association (CAA) is the advocate for agritourism businesses and communities. It evolved out of the Colorado Tourism Office Heritage & Agritourism Committee (now the Destination Development Committee).

In the CAA September newsletter, an article detailed the impact of Agritourism on the economy of Colorado:

The number of Colorado farms generating income from agritourism and recreational services grew to 1,056, up from 864 in 2012, and the income more than doubled! (from the CO Dept. of Ag 2017 census data- as of April 11, 2019)

Outdoor Recreation Economy in Colorado creates:

- 511,000 Jobs
- 10% of the state's GDP
- \$37B Consumer Spending
- \$21B Wages & Salaries
- \$9B State, Local & Federal Tax

### Other stats on outdoor rec:

- 92% of Coloradans Recreate outdoors at least once every few weeks.
- Total Economic Contribution: \$62B
- Over the past 5 years the economic contribution of outdoor recreation in Colorado nearly doubled. Jobs in this sector alone grew by 63%.

### Colorado Tourism (at a glance) Creates:

- \$20.9B in traveler spending
- Which creates \$1.28B in state and local taxes
- 171k iobs
- 989,000 International visitors


