We are disappointed that we had to cancel our July 14th summer picnic in Lincoln Park.

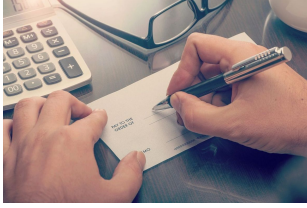
