



ORDINANCE 2013 - 12

AMENDMENT TO ORDINANCE 1997-5  
OF THE TOWN OF CLOVERDALE

**WHEREAS** the various rules ordinances and traffic regulations for the Town of Cloverdale are in need of review, and;

**WHEREAS** after due consideration a number of adjustments are appropriate.

**COMES** now the Town Council of the Town of Cloverdale and enacts the following changes to various portions of the Town Code,

**BE IT ENACTED THAT:**

Section 8.10 of the Town Code of the Town of Cloverdale will be amended by replacing the existing text with the following:

**SECTION 8.10 HIGHWAY USE RESTRICTION**

(A) Restriction:

- (1) All of the local streets in the Town of Cloverdale, excepting State Highways, shall be restricted to automobiles and pick-up trucks, except where posted as Truck Route as set out in Section 8.10 (a) 4.
- (2) This Article shall not apply to buses of less than forty-five (45) feet in length or vehicles making local deliveries, provided that such vehicles do not exceed 26,000 pounds gross weight.
- (3) This Article shall not apply to vehicles directly involved in the construction, reconstruction, repair or demolition of structures or improvements if the activities are covered by permits obtained from the Town of Cloverdale.
- (4) The restrictions herein may not be enforced until signs giving notice of such restrictions are erected upon the streets and right-of-way.
- (5) Authorize Truck Routes:
  - (i) **Truck Route to service Endeavor, 2 S. West Street, Cloverdale, IN** – off of Hwy. 231 west of Market Street to West Street, south to business and waste water plants.
  - (ii) **To Service Cloverdale Ag Center, 303 W. Robert Weist Avenue, Cloverdale, IN** – Off of Hwy 231 turn west on Robert Weist Avenue.

- (iv) **To Service Cloverdale Building Supply, 51 E. Logan Street, Cloverdale, IN** – off of Hwy 231 turn east on Logan Street, to Lafayette Street, turn north on Lafayette Street to turn west at alley. Please turn left or right back on Hwy 231, do not cross 231 into the other alley – no outlet.
- (v) **To Service Mike Buis, 151 S. Lafayette Street, Cloverdale, IN** – off of Hwy 231 turn east on Logan Street to Lafayette Street, turn south to business on left. To leave business go north on Lafayette Street to Logan Street, turn west on Hwy 231.
- (vi) **To Service Putnam Plastic, 30 W. Stardust Road, Cloverdale, IN** – off of Hwy 231 turn west on Star Dust Road to business on left.
- (vii) **To Service Value Market 4 W. Star Dust, Cloverdale, IN** - off Hwy 231 turn west on Star Dust Road to business on left.
- (viii) **To Service Family Dollar 4 West Mill Street, Cloverdale, IN** – off of Hwy 231 turn west on to Mill Street, to business on right.

(B) Violation:

- (1) Shall be punishable by a fine of One Hundred Fifty Dollars (\$150.00) for each violation.
- (2) Any operator or owner of a vehicle who is cited for a Violation of the Article more than one time in any calendar year may be subject to a fine of not more than Five Hundred Dollars (\$500.00) for each subsequent violation. (Persons alleged to have violated the Article more than one time in any year may be cited to the Putnam Superior Court.

This ordinance is effective upon passage and publication, this 14<sup>th</sup> day of JAN, 2014
