

**Agreement to Participate with Waiver and Release Liability**

This includes ordinary negligence on the part of this Travel Team, its' agents, employees, sponsors, volunteers, owners, lessors of the premises and all other that are involved.**

**In consideration of my being allowed to participate in this event and activities, I hereby release and covenant not to sue any of its coaches, volunteers, agents, instructors and agents for any and all present and future claims resulting from ordinary negligence on the part of B 3 Extreme Sports Facility or others listed for property damage, personal injury or wrongful death, arising as a result of my engaging in or receiving instruction by B 3 Extreme Sports Facility programs and the activities incidental thereto, wherever, whenever or however same may occur. I hereby voluntarily waive any and all claims that may be made by me, my family, estate, heirs or assigns resulting from ordinary negligence, both present and future.**

**Furthermore, each of the undersigned hereby agrees to release and forever discharge B 3 Extreme Sports Facility and all Parties associated with this B 3 Extreme Sports Facility from any and all liabilities, claims, actions, damages, costs or expenses of any nature whatsoever, whether in law or equity, known or unknown, that any of the undersigned ever had, now has or hereafter can, shall or may have against any of the Participants arising out of or in any way related, directly or indirectly, to Player's participation in B 3 Extreme Sports Facility events. Further, I am aware that Dodgeball is a vigorous team sport that at times involves severe cardiovascular stress and violent physical contact. I understand that Dodgeball involves certain risks, including but not limited to death, serious neck and spinal injuries resulting in complete or partial paralysis, brain damage, injury to virtually all bones, joints, muscles and internal organs, and that equipment provided for my protection may be inadequate to prevent serious injury. I further understand that baseball involves a particularly high risk of ankle and knee injury.**

**I understand that this waiver is intended to be as broad and inclusive as permitted by the laws of the State of Colorado and agree that if any portion is held invalid, the remainder of the waiver will continue in full force and effect. I further agree that the venue for any legal proceeding shall be in the State of Colorado.**

**I affirm that I have read and fully understand the content of this Waiver and Release Liability and am freely signing this agreement, and that I am giving up my legal rights and/or remedies which may be available to me for the ordinary negligence of this Travel Team or any of the parties listed above.**

**For parents/guardians of participants of minority age (Under 18 years old at the time of this registration) This is to certify that I, as parent/guardian with legal responsibility for this Participant, have indeed read the Waiver and Release Liability and I agree, for myself, my heirs, assigns and next of kin, to release and hold harmless and waive subrogation to B 3 Extreme Sports Facility and all others from any and all liabilities incident to my minor child's involvement or participation in these outlined activities or programs as provided above, even if arising from ordinary negligence, to the fullest extent permitted by law. I further agree to instruct my minor child to comply with the stated and customary terms and conditions for participation in the program or activity itself. If they are behaving in such a way that is not in compliance with the terms and conditions for participation in the program or activity, I will remove my child from participation and bring such to the attention of the nearest official immediately.**

**Each of the undersigned parent(s) or guardian(s) of Player hereby agrees to indemnify and hold B 3 Extreme Sports Facility harmless from and against any and all liabilities, claims, actions, damages, costs or expenses of any nature whatsoever, whether in law or equity, known or unknown, incurred by any Parties and arising out of or in any way related, directly or indirectly, to Player's participation in any activity at B 3 Extreme Sports Facility.
