

Ordinance No.740-

An ordinance appropriating certain Money's.

Be it ordained by the Mayor and Board of Commissioners of
th City of Garnett, Kansas,

Section One :- that the sum of ~~XXXXXX~~ Four Hundred &

Section Six :- that the Mayor and city clerk be and are hereby authorized
and instructed to draw warrants of the city Treasurer to pay the bills
allowed in the forgoing sections of this Ordinance.

Section Seven:- that this ordinance shall take effect and be in force
from and after its passage by the Board of Commissioners and its approval
by the Mayor .
