Propane Tank Safety

Use a broom instead of a shovel when clearing snow off the tank or around the exposed piping, regulator, gauges, or tubing.



When clearing the roof, avoid shoveling snow onto exposed piping around the propane regulator near the building or onto the propane tank and piping, as well as any meters or other piping that may be in use.

Protect and Conserve

Drip your faucets. Yes, use water to save water; leaks can be expensive. * Consider using the water from your pet's bowl or fish tank to water your plants. * Stay on stop of removing your pet's waste during the winter - it is more concentrated in snow, will run off in the spring into streams and rivers and can raise bacteria and nutrient levels. * Salt used to melt ice can damage fresh water ecosystems. Consider using calcium chloride (CMA) alternatives. * Install a tankless water heater - waste less water while waiting for faucets to warm up.
