LONE MOUNTAIN QUARTETTE COMMUNITY ASSOCIATION EXTERIOR PAINTING AND COLOR PALETTE STANDARDS AND GUIDELINES

INTRODUCTION

Community Color Palette - The Board of Directors has adopted a color palette for the exterior painting of units which includes the original color palette established by the developer in addition to new color schemes added and approved by the Board of Directors. The color palette is attached to these standards and guidelines as **Addendum A**. Included with the color palette is a list by address which specifies the original builder color scheme of each unit. This list is attached as **Addendum B** to these standards and guidelines. The Exterior Painting and Color Palette Standards and Guidelines ("Guidelines") were developed with the assistance of a retained professional to ensure that the Guidelines are consistent with the aesthetics and look of the community.

GUIDELINES

1. When selecting a color scheme for the unit exterior, owners have two options. Owners may either repaint their units using their original exterior colors as designed by the builder or select one of the new color schemes provided. *See* Addendum A.

2. Adjoining units must be painted using the same color scheme. At least thirty (30) days prior to the commencement of unit painting, each adjoining unit owner must submit a Painting Notification form (Addendum C) to the Board of Directors. The painting notification form is required to verify that the adjoining neighbor is aware of, and agrees to the color scheme selected by the adjoining unit owner. When adjoining unit owners are in agreement as to the selection of a color scheme, the adjoining unit owners must paint the exterior of their unit within one hundred eighty (180) days of each other. Alternatively, if adjoining unit owners cannot agree on a scheme from the new color palette, they must repaint using the original color scheme from the developer palette. In the event a dispute arises between adjoining unit owners regarding the selection of a new color scheme, the unit owners may request an informal meeting with the Board and/or ARC committee to assist in resolving the dispute.

3. After a unit owner has completed painting of their unit, the Association may inspect the unit to verify that the unit has been painted the color scheme specified on the painting notification form.

4. Neighboring units must alternate color schemes. For the purpose of these Guidelines "neighboring units" shall be defines as any unit on the same side of the street, directly in front of or behind the unit being painted".

5. If a unit owner would like to use any color not specified on the community color palette, or a different combination of colors then specified on the community color palette, the unit owner must submit a written variance request for approval by the Board of Directors.

6. Garage doors must be painted to match the main body color of the unit.

7. Any exterior wiring/conduit attached to the unit exterior must be painted to match the main body color of the unit.

8. All exterior painting must be completed in a workman like manner.

9. Iron fencing on an Owner's lot must be painted in color DE 6389 Fallen Rock.

10. The Board shall have the right to determine that a unit owner has failed to properly maintain their unit, and exterior painting is required. At the Board's discretion the Board may utilize the services of a professional to assist in making the determination that a unit requires exterior painting. In cases where the Board has determined that the unit exterior requires painting, the unit owner must repaint the entire exterior of their unit. Once a determination has been made by the Board that the exterior of a unit must be painted the Association shall provide the unit owner with written notice of that determination and set the matter for hearing before the Board. Subject to any agreed upon procedures or variances following the hearing with the Board, the unit owner shall have one hundred and eighty (180) days to paint the exterior of the unit.

11. When determining when a unit requires exterior painting, the Board of Directors shall use the following criteria:

a. Noticeable signs of fading, discoloration or stains;

b. Flaking, bubbling, chipping, peeling or cracking paint;

c. Rust on any exterior metal surface.
