RESOLUTION NO.: SL- 17 -2018

**TITLE: REQUEST TO ACCEPT FUNDS FROM BIA FOR ROAD
MAINTENANCE SERVICES FROM FISCAL YEAR 2018**

WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Council; and,

WHEREAS, the Summit Lake Paiute Council has the responsibility for the general welfare of its tribal membership including tribal natural resources; and

WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the boundaries of the Summit Lake Paiute Reservation; and

WHEREAS, the Summit Lake Paiute Council has been organized to represent, develop, protect and advance the views, interest, education, resources, and general welfare of the Summit Lake Paiute Tribe membership; and

WHEREAS, the Summit Lake Paiute Council has organized a Natural Resources Department to provide technical expertise and services to manage air, water, soil, fish, wildlife, and plants within the Summit Lake Paiute Reservation and off-Reservation areas considered the aboriginal homeland of the Summit Lake Paiute Tribe; and

WHEREAS, the Summit Lake Paiute Council supports natural resources management that protects, conserves, and enhances plants and wildlife endemic to the Summit Lake basin and aboriginal area of the Summit Lake Paiute Tribe; and

WHEREAS, for many years the Natural Resources Department has been performing maintenance on roads within the Summit Lake Reservation that are part of the Indian Reservation Road system; and

WHEREAS, the Summit Lake Paiute Tribe was recently notified of a Fiscal Year 2018 allocation of road maintenance funds for improvement of conditions of unpaved roads in the Indian Reservation Road system; and

NOW THEREFORE BE IT RESOLVED, that the Summit Lake Paiute Council,

hereby submits to the Bureau of Indian Affairs, Division of Transportation, a funding request for an equal portion of the \$214,628.00 allocated to the Western Region to perform maintenance operations on BIA Routes 0001, 0002, 0003 totaling 9.6 miles of Indian Reservation Road system roads on the Summit Lake Indian Reservation; and

BE IT FINALLY RESOLVED that the Summit Lake Paiute Council does not waive, alter, or otherwise diminish its Sovereign Immunity, whether expressed or implied, by virtue of this grant agreement for any and all administrative or legal action which may arise directly or indirectly from the same.
