

## Priority Registration 2026

### **Parents:**

As always, the school will offer priority registration for Summer School and the Fall of 2026 to families with children currently enrolled at the Learning Tree. ***\*\*This is also the time that you would register any siblings\*\**** Priority registration applications must be received by Friday, February 6, 2026, to receive priority status. The system that we use for all of our registrations is not equipped with a re-registration format, so you will need to print the Registration Forms (one for Summer, one for Fall. Please fill out the applications and return by the due date – February 6, 2026. ***\*\*please print one per child\*\**** Once we have processed your registration, we will provide you with a bill for any Registration Fees and/or Summer School deposits due. Your spot will not be guaranteed until all payments have been made. Last day to make any payments is February 17, 2026. Open registration to the public begins March 9<sup>th</sup> at which time any remaining spaces can be taken.

Every new enrollment period, there is a slight tuition increase to cover overall rising costs and inflation, payroll increases, building improvements, new materials, etc. This year, the increase will be around 5%. The new tuition rates, which will go into effect at the beginning of Summer School, are also included for you to review.

To continue to offer our students the most consistent routine and scheduling, the following options are available for attendance - 5 DAYS (Monday through Friday), 3 DAYS (Monday, Wednesday, and Friday), or 2 DAYS (Tuesday and Thursday). We offer HALF DAY (8:50-12:00) and FULL DAY (7:00-6:00) options for any of the three attendance choices. *\*Due to the ratios and small class size, the Toddler Program is a 5, full day program ONLY.*

### **Summer School:**

**Summer School will run from Monday, June 8<sup>th</sup> through Thursday, August 27<sup>th</sup>.** Summer School is optional, and enrollment is NOT required for Fall attendance. However, if you do plan to sign up for the Summer Program, please thoroughly read the details below.

Summer School is a **12-week, continuous program** (no tuition breaks for vacations or not attending) that concludes the Thursday before the Fall Semester starts. There will be three, 4-week payments billed during Summer School.

Payment due dates will be on:

- **Monday, June 8<sup>th</sup>**
- **Monday, July 6<sup>th</sup>**
- **Monday, August 3<sup>rd</sup>**

***\*SCHOOL WILL BE CLOSED ON - JUNE 19<sup>TH</sup>, JULY 3<sup>RD</sup> & AUGUST 28<sup>TH</sup>.***

There is Non-Refundable/Transferrable Registration Fee for Summer School of **\$100.00** per family. \*Summer school enrollment is on a first come basis for each age group due to its limited availability.

**In addition to the NON-REFUNDABLE/TRANSFERRABLE** Registration Fee required at sign-up, a deposit of **\$100.00** per family is also due upon acceptance to the school. This \$100.00 deposit will be credited back to you on the August 4<sup>th</sup> billing date, assuming that you complete the Summer School program in its entirety.

***\*If your plans change and you no longer wish to attend the Summer Program, the last day to drop out of Summer and still receive your \$100.00 deposit back is: APRIL 10, 2026.***

***\*FOR STUDENTS CONTINUING IN FALL 2026-- Dropping out of the Summer Program after the April 10, 2026 deadline, will not only result in a forfeiture of the \$100.00 summer school deposit, but also a possibility of the loss of your Fall space. In the event that you have more than one student enrolled in the Summer Program, ANY withdrawal, (ex. both children or just one), will result in a full deposit forfeiture.***

***\*FOR GRADUATING/EXITING STUDENTS (NOT ATTENDING FALL 2026) – Notification of your child's last day of summer school, with at least 2 week's notice, will be required for deposit refund and proration of tuition. \*Check your child's new school's start date and let us know their last day as soon as possible. Or, if you already know when their last day will be, please note it on the Summer School Registration Form.***

***\*\*\*Students registering for Pre-School or Pre-K MUST BE FULLY POTTY TRAINED. If your child is scheduled to attend one of those programs, takes any portion of the summer off, and they are not potty trained when they are scheduled to return to school, they will be placed on a waiting list.***

### **Fall:**

Fall Semester begins Monday, August 31, 2026 (Closed the following Monday, September 7, 2026, for Labor Day) There is a \$100.00 Per Student (Non-Refundable/Transferrable) Registration Fee required for returning students. For siblings new to the program, there is a NEW student Registration Fee of \$150.00 (Non-Refundable/Transferrable).

\*For students who are enrolling in Pre-K (4 years old by Sept. 1, 2026), please be reminded that it is a 5-day program in order to assist with Kindergarten readiness. Pre-K aged students, not wishing to attend 5 days, may enroll in the Part-Time Pre-K program that is joined with the oldest Pre School students. Please note that there are a limited number of spaces in that class.
