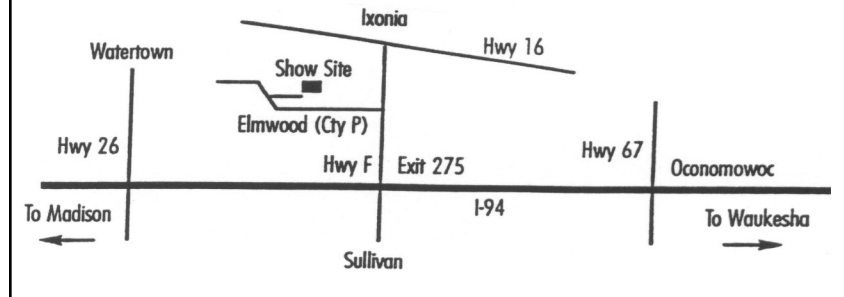
DIRECTIONS TO TRIAL SITE

From the East:

Take Hwy 16 (about 5 miles west of Oconomowoc). Turn South on County F. (Ixonia). Turn West (right) on Elmwood. Turn East (right) on Cedar Dr.
