

An ordinance appropriating certain money's.

Be it ordained by the mayor and Commissioners of the city of Garnett Kansas

Section One :- that the sum of *One Hundred and Sixty Two and 2/1000* Dollars be and the same is hereby appropriated out of the General Fund in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 1st day of January 1917. a list of which may be found on page of the journal of the proceedings of the Board on said date.

Section Two:- that the sum of *Seven and Ninety Eight and 76/1000* Dollars be and the same is hereby appropriated out of the water works funds in the habds of the city treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 1st day of January 1917. a list of which may be found on page of the journal of the proceedings of the Board on said date

Section Three :- that the sum of *One Hundred and Twenty Two and 60/1000* Dollars be and the same is hereby appropriated out of the Street Fund in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 1st day of January 1917. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

Section Four :- that the sum of *Seven Hundred and Fifty Six and no/1000* Dollars be and the same is hereby appropriated out of the Electric Light Fund in the hands of the City Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 1st day of January 1917. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

Section Five :- that the sum of *Seven and 75/1000* Dollars be and the same is hereby appropriated out of the Cemetery Fund to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 1st day of January 1917. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

Section Six :- that the sum of *Three Hundred and Eighty Three and 68/1000* Dollars be and the same is hereby appropriated Out of the Property Paving Tax Fund No 2 in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 1st day of January 1917. a list of which may be found on page of the journal of the proceedings of the Board on said date.

~~Section Seven :- that the sum of Dollars be and the same is hereby appropriated out of the Property Paving Tax Fund No in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 1st day of January 1917. a list of which May be found on page of the J urnal of the proceedings of the Board on said date.~~

Section Seven that the sum of *Twenty and no/1000* Dollars be and the same is hereby appropriated out of the Fire Department Fund in the hands of the city Treasurer to pay the Bills allowed against said Fund at ~~the same~~ regular meeting of said Board held on the 1st day of January 1917. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

Section *Eight* that the Mayor and city clerk be and are hereby authorized and instructed to draw warrants on the city Treasurer to pay the Bills allowed in the forgoing sections of this ordinance.
