#### Missouri Rural Services Workman's Comp Trust Renewal Bill

City Administrator Dan Bryan spoke regarding the visit from Russ Vaness. The meeting with Russ was regarding the need to reduce the City of Desloge claims. \$50,000 - \$75,000 should be our annual cost however; we are paying \$132,959.00, which is nearly double of what we should be paying annually. This is simply a reflection of the amount of claims. 2007 and 2008 is the last time we received any dividends. The city admin has been disbursing safety emails to supervisors to share with their departments. Alderman Gremminger requested to initiate a safety incentive every quarter. Alderman Gremminger requested to have something prepared regarding the safety incentive for the next regular monthly meeting. Alderman Gremminger made the motion to approve the payment to the Missouri Rural Services Work Comp Trust for \$132,959.00 and Alderman Shaw seconded the motion. Approval for payment of Police Department Vehicle

Police Chief James Bullock spoke about contacting the Highway Patrol to be on a waiting list for a vehicle, they said it would be around March. Police Chief called last week to check and see where Desloge would be on the list. The Highway Patrol stated they had a 2016 black Ford Explorer with 64,000 miles available for the City. The price is \$18,900. With the Insurance reimbursement form Officer Cash's car in the amount of \$6,088.00 and the reimbursement from Officer Judges car in the amount of \$9,680.00 for a total of \$15,678.00. The Police Department has also been raising money and getting donations for the K-9 car. The new vehicle will be the new K-9 vehicle therefore \$3,182.00 will be taken from this cash fund donation account for the K-9 vehicle. We have \$9,460.00 of insurance reimbursement available from equipment on the crashed vehicles to use to equip the new K-9 vehicle. Mayor David Kater commented on donors for the Police K-9. The Mayor and board would like to see a list of regular donors to honor them. Alderman Shaw requested publicity and photos when the vehicle arrives. Alderman Hodge made the motion to approve the payment of the new Police Department vehicle and Alderman Gremminger seconded the motion. Update on VW Trust Fund Grant

City Administrator Dan Bryan spoke about submitting the proposal on the fire truck for the VW Trust Fund Grant. The city of Desloge was not selected as a recipient of the VW Trust Fund Grant. Out of fifty applicants, they gave ten awards three went to Audrain County road and bridge, two to the City of Fulton, one to the City of St. James, one to City of Waynesville, one to Howell County, one to Rolla Municipal

Utilities and one to Wayne County. For Transit buses, they gave out roughly \$400,000.00 of the 1.5 million to Columbia Public Transit for four buses. The remainder of the money went to public school systems for school buses. The City Administrator though the one thing that may have hurt us was having a big-ticket item such as the fire truck for \$280,000.00
