Zoning Officer Report: There is a report in the Boards packet. There is a communication tower on Orangeville Center Road, that is being replaced and 8 antennae added.

Highway Superintendent Report: Eagle had an event where they had to utilize their AID, so we are looking into training on CPR for our employees. Tracy Horton called and we signed up new employees. Our snow and ice contract is here to be reviewed and signed. Put in our last round of fiber – Townline to Royce and Royce to 20A. Sealing 9 miles – oil / fiber / oil / stone. It is supposed to last 7-8 years, a little more expensive. Bantam road, road washes out, some areas 2-3 ½ feet gone in spots. There was discussion regarding the BAN payment on our truck. 2014 – going on 10 years old, and we will pay off \$75,000 in 2023. We will go back on winter hours next month after Board Meeting.

Town Clerk Report: The Towns total revenue for the month of August 2023 was \$1,344.00, \$432.00 for dog licenses, \$40.00 for registrar, \$80.00 for marriage and \$60.00 for Zoning. We had 27 renewal and 7 new licenses. To the general fund, \$60.00 for Zoning, \$460.00, \$807.00 for DEC, \$40.00 Marriage, \$5.00 for late fees. We disbursed \$240.00 to Wyoming County, \$63.00 to Ag and Markets for dogs, \$732.49 to DEC, \$22.50 to NYSDOH and \$256.01 to the General Account. (DEC-\$44.51, Marriage-\$17.50, Dog license #134.00 and \$60.00 for Zoning)
