# FEBRUARY 13, 2025 MEETING MINUTES

- 1) Call the Bexar County Emergency Services District 10 meeting to order and establish a quorum. Commissioner Kelley called the meeting to order at 7:01 PM (19:01). A quorum was established with Commissioner Kelley, Commissioner Wallace, Commissioner Lazar, and Commissioner Hicks present. Commissioner Yates was absent.
- 2) Invocation: Pledge of Allegiance to the American Flag. The Pledge of Allegiance was recited.
- 3) Citizens to be heard (three (3) minute limit). Battalion Chief Haverda spoke for several minutes.
- **4) Approval of meeting minutes for January 10, 2025.** Commissioner Hicks motioned to approve the meeting minutes from January 10, 2025, as presented, with a second from Commissioner Lazar. The motion carried with 4-Aye and 0-Ney.
