**First Round Deadline: April 15, 2025 or until filled. Spaces are limited to a maximum of 25 Artists.  
Prices may increase after first round deadline.**

**1. Agreement:** This Agreement is between the Vancouver Wine & Jazz Festival<sup>®</sup> (herein called "Festival") and the Artist on this Application (herein called "Artist"). The City of Vancouver is herein called "City." The Festival and Artist are mutually entering into an Agreement to display, promote, and sell original art created by Artist at the Vancouver Wine & Jazz Festival. Dates for the 2025 Festival are Friday, Saturday and Sunday, August 22, 23, 24. Hours: 4-10 PM Fri; 11 AM-10 PM Sat; and 11 AM – 9 PM Sun. Hours and dates are subject to change, and do not affect this Agreement. Changes to this Agreement can only be made by the Festival.

**2. Booth Fee:** Artist must submit the Booth Fee with this Application. If Artist is not accepted by the Festival, all fees are refunded to Artist. If Artist is notified as accepted by the Festival and then cancels for any reason after notification of acceptance, the fees are not refunded. Artist receives a maximum of 3 Exhibitor passes per day (1 for Artist, 2 for your assistants. Passes cannot be shared or transferred.) Artists may not share, split or co-op any space, only 1 Artist per space.  
**Booth Fees with electricity are: \$350 for Single Space, \$700 for Double Space.**

**3. Returning Artists:** A Returning Artist is any artist who has participated in any previous Festival. If you are a Returning Artist, you are automatically accepted and GUARANTEED a space if you apply by April 15, 2025.

**4. First Time Artists:** The Festival is a juried event for professional Artists and Crafters. No imports or art by secondary parties. First-time Artists must submit art samples with this application for the jury. You may submit your website, OR mail photos, a promotional brochure, digital media (such as a flash drive) or other media which shows your work. Artists are accepted upon approval by jury, and if your payment is included with the Application. Applications without payment are not considered. Artists are notified of acceptance after deadlines.

**5. Space & Electricity:** This is an outdoor event. The Festival provides an assigned space. Artist should provide a canopy or tent for their space. Artist may use pedestals, panels, easels, etc. to display art. Each space is provided one electrical outlet with a 5-amp / 600-watt / 120-volt electrical outlet. Artist provides their own lights or other electrical devices as needed. Artist agrees to maintain and staff their booth during Festival hours. Set up is Thursday August 21 from 10 AM – 3 PM; or Friday August 22 from 7 AM – 10 AM. Breakdown is Sunday after the official close of Festival. **NO ARTIST MAY BREAK DOWN PRIOR TO OFFICIAL CLOSE OF FESTIVAL.**

**6. Sales & Security:** Artist sales, and all local or state sales taxes are the sole responsibility of the Artist. Artist and/or Artist assistants will be issued an Exhibitor Wrist Band for admission which must be worn at all times. Artist or an Artist assistant must remain at the booth during the Festival. The Festival is fenced during official hours. Security will be provided beginning Thursday at 10 AM through the official close of the Festival on Sunday at 9 PM. Any damage or theft of art, materials, or products, or of any personal belongings of Artist or Artist assignee during the hours of the Festival, beginning with setup through the official close of Festival; or overnight, at setup or breakdown; or at any other time during the Festival is the sole responsibility of the Artist and is not the responsibility of the Festival, Bravo! Vancouver, its Board, managers, volunteers, staff, or assignees, nor the City. Artist is responsible for their own setup and breakdown. All Artists and Vendors shall act in a professional manner. Management reserves the right to remove any person for any reason. Such person shall not be entitled to refunds or any compensation.

**7. Insurance, Liability and Hold Harmless:** All work is done at Artist’s risk. Artist shall take all necessary precautions and shall be responsible for the safety of Artist, Artist employees, agents, assigns, and subcontractors in the performance of the work hereunder. Any intentional breach of this Agreement, any personal injury or any damage to Festival venues, Esther Short Park, City property or private property, or any damage or injury to Bravo! Vancouver or the Festival due to unintentional, negligent, or intentional acts on the part of Artist or his assign and sustained by any organization or individual including but not limited to Bravo! Vancouver and its Board, the Festival, the City of Vancouver, the Artist, Artist employees, his agents and assigns, Festival patrons, volunteers, staff, subcontractors, or any other individual shall be the sole responsibility and liability of Artist. Any damages to Festival venue, Esther Short Park or to other City property attributed to the Artist and assessed by the Festival or assessed by City Parks Staff shall be paid directly by the Artist to the Festival. Failure to pay any such damages will result in legal action to obtain compensation for damages. **Artist shall maintain General Liability Insurance, and is responsible for insuring art, employees, agents, assigns, and subcontractors in the performance of the work hereunder, and must include “Bravo! Vancouver/Vancouver Wine & Jazz Festival” as Additional Insured on their liability policy. Any Artist NOT holding valid liability insurance performs all work at their sole personal risk and assumes all liability.** The Artist shall defend, save & hold harmless Bravo! Vancouver, the Festival, and the City of Vancouver, & their respective officers, agents, employees, staff, volunteers, sponsors, and assigns from any claims, damages, losses, liability, or expenses (including all attorney fees) which may arise from the negligent performance, unintentional or intentional breach of this Agreement by the Artist. The laws of the State of Washington shall govern the rights and liabilities of the parties. Any lawsuit must be brought in Clark County District or Superior Court in Vancouver, Washington, and the prevailing party shall be entitled to an award of reasonable attorney fees against the other party. The Festival may void this Agreement at any time for any reason. In consideration of the items herein, the parties sign:
