Chairman Thomsen led the Pledge of Allegiance. Upon Roll Call, Trustees Trish Dunn, Jerry Rust, Ted Sator, Tom Stevener and Jeff Thomsen were present. After roll call, Chairman Thomsen announced that a quorum was present for the transaction of business.

Motioned by Trustee Rust, seconded by Trustee Stevener, to approve the agenda. All Trustees present voted "Aye". Motion passed and approved with a 5-0 vote.

APPROVAL OF MINUTES

Motioned by Trustee Stevener, seconded by Trustee Rust to approve the April 10, 2018, regular meeting minutes. All Trustees present voted "Aye". Motion passed and approved with a 5-0 vote.

- a. Financial Report The financial report and the bills of the month were distributed and viewed by all Trustees in attendance. Motioned by Trustee Dunn, seconded by Trustee Rust to approve the financial report and pay all the bills of the month. All Trustees present voted "Aye". Motion passed and approved with a 5-0 vote.
- b. Administrator's Report Carla Ayala presented her report to the Trustees. Registration is now open for the MML Annual Conference will be held in Branson, MO, September 16-19, 2018. The next BRPC General Membership meeting is scheduled for June 25, 2018.
- c. Planning and Zoning Commission A meeting was not held on May 2, 2018.

UNFINISHED BUSINESS:

- a. Request for Exemption For Special Community Event Noise Chairman Thomsen explained the reason behind the request for exemption and read last year's limitations. Chairman Thomsen would like this year's limitations to read, " Approved on the conditions that the noise level at the sound board/speakers not exceed an average of 85 dba with noise levels not to exceed 90 dba. The Owners Association, and its Trustees, and Innsbrook Corporation are responsible for monitoring and maintaining these noise limitations. The Owners Association is to retain an independent company to provide the sound system and operator of the system for all concerts. Any violation of these limitations deemed by the Board of Trustees of the Village of Innsbrook to have been for an unreasonable period of time shall result in the Owners Association terminating the relationship with the company operating the sound system and/or the entertainers from being used for any future events at Innsbrook." For the Request for Memorial Day Boom (05/26); 4th of July Fireworks (07/07) and New Years Eve Fireworks (12/31), motioned by Trustee Dunn, seconded by Trustee Rust to approve the request with no limitations. By roll call vote, Trustee Dunn - "Aye", Trustee Rust - "Aye", Trustee Sator - "Aye", Trustee Stevener - "Aye", Trustee Thomsen - "Aye". All Trustees present voted "Aye". Motion passed and approved with a 5-0 vote. For the request for Summer Breeze Concert Series (06/02-08/25), motioned by Trustee Stevener, seconded by Trustee Rust to approve the request with additional limitations. By roll call vote, Trustee Dunn - "Aye", Trustee Rust - "Aye", Trustee Sator - "Aye", Trustee Stevener - "Aye", Trustee Thomsen -"Aye". All Trustees present voted "Aye". Motion passed and approved with a 5-0 vote
- b. BILL NO. 251 AN ORDINANCE AMENDING THE VILLAGE OF INNSBROOK'S PUBLIC NUISANCE ORDINANCE BY THE ADDITION OF SUBSECTIONS RELATING TO THE USE OF PROPERTY AND WASTEWATER TREATMENT SYSTEMS (ORD. NO. 248) Motioned by Trustee Stevener, seconded by Trustee Sator to have the second reading of Bill No. 251 by title only. All Trustees present voted "Aye". Motion passed and approved with a 5-0 vote. Chairman Thomsen read Bill No. 251 twice by title only. Chairman Thomsen opened the floor for discussion, there being none, by roll call vote, Trustee Dunn "Aye", Trustee Rust "No", Trustee Sator "Aye", Trustee Stevener "Aye", Trustee Thomsen "Aye". With a 4-1 vote, Bill No. 251 was enacted as Ordinance No. 248 of the Village of Innsbrook, Missouri.

- a. 2018-2019 Fiscal Year Budget Trustees were provided with a DRAFT copy of the 2018-2019 Fiscal Year Budget. Changes and/or adjustments to that draft version were discussed and made.
- b. Set Public Hearing Motioned by Trustee Dunn, seconded by Trustee Stevener, to set a public hearing for June 12, 2018 at 5pm for the approval of the 2018-2019 Fiscal Year Budget. All Trustees present voted "Aye". Motion passed and approved with a 5-0 vote.

Motioned by Trustee Sator, seconded by Trustee Stevener, to adjourn the regular meeting and enter executive session. By roll call vote, Trustee Dunn "Aye", Trustee Rust "Aye", Trustee Sator "Aye", Trustee Stevener "Aye" and Chairman Thomsen "Aye". All Trustee's present voted "Aye". Motion passed with a 5-0 vote. Meeting adjourned into executive session at 6:05 PM.
