**To apply, the following is required:**

- Each person, 18 years of age and over, must fill out a complete application.

- Applicants must have current identification in the form of driver's license, state ID, military ID, or passport.
- A \$225 non-refundable administrative fee must accompany this application. The non-refundable administrative fee will be deposited upon receipt of the application and will be refunded **ONLY** if the application is rejected by Main Street Commons. **Fee must be in check form (Personal Check, Money Order, Cashier's Check) made out to Main Street Commons.**
- We generally process applications in 3-5 business days, but applications can take longer if more information is required.
