## **Zoning Board:**

- Act 181/Act 250 Update: The Zoning Board presented an update from NVDA on Act 181, an addition to Act 250, which aims to streamline housing development in larger towns. It doesn't significantly affect Lowell due to its size and structure.
- The zoning board wants to move the village border on the map to include the bowling alley and general store.
- There is concern that expanding the village limits could allow for low-income housing development without Act 250 permitting, potentially impacting local input.
- The State wants to compact everybody into the village center.

#### **Dog Complaint:**

- A complaint was received about dogs running loose and causing issues with neighbors.
- The dog owner was reminded of their responsibility to keep their dogs on their property and under control.
- A suggestion was made to use a perimeter system to keep the dogs contained.
- The dog owner felt targeted and that the complaints were exaggerated.
- The select board will check into the other dog complaints.

# **Starlink Internet:**

- Discussed switching to Starlink for faster internet service at the town office and library.
- There were concerns about linking phone service to Starlink due to potential outages.
- The decision was tabled for further discussion.
