Which Medicare or Health Plan Should One Choose For 2026? - Virginia Wright

The AARP Club of LOW will hold its meeting on Monday, October 20, 2025 at the Clubhouse of Lake of the Woods. There will be time for networking and greeting other members and welcoming visitors starting at 9:30 AM, with the program beginning promptly at 10:00 AM.

We welcome as our Guest Speaker, Jennifer Zamora, an Aging Services support Coordinator for Encompass Community Supports, who will give us a presentation on Medicare 101 and Open Enrollment. Topics to be covered are Medicare Basics, Medicare Savings Plans and Extra Help, Open Enrollment, Advantage Plans and Part D. She will be joined by Toni Browning, the Supervisor of Aging Services Support Coordination. As one of Virginia's 25 Area Agencies on Aging, ECS assists individuals 60 years and older, and their families, with long term care needs by providing resources and services they need to maintain their independence, dignity, right to make choices, and participation in the community. They provide an array of services to meet multiple needs.

They serve Culpeper, Orange, Madison, Rappahannock and Fauquier Counties. Their Senior Centers provide a nutritious lunch and the opportunity to socialize with peers. Their Home Delivered Meals program provides nutritious frozen meals delivered to homebound individuals who have no one to shop or prepare meals for them.

As part of the Virginia Insurance Counseling and Assistance Program, they assist Medicare beneficiaries by providing unbiased guidance with their Medicare. They also assist beneficiaries with enrolling in a Medicare Part D Plan or Medicare Advantage Plan. Other supportive services include Advocacy, Outreach and Options Counseling. The services can be


on the morning of November 24th and distributed from 139 Harrison Circle, Lake of the Woods.
