- E. Ting, Mark Gotto, Ting City Manager (absent)
- F. City of Centennial, Mayor Stephanie Piko
 - She outlined the new Centennial Community Grant Program
 - Some communities have already applied for \$10K grants
 - And a number have applied for the \$500 grants, as well.
 - Community Center Park is now wired with Ting wi-fi.
 - Passport applications are bac; appointments may be out a few months. Register online for that appointment and more info <u>here</u>.

- The last 2 Community Social events are scheduled for: District 2, 7/13; Dist. 3, 7/29.
- Sat., 8/14, 6-10pm: Centennial Under the Stars in the Park.
- Sat., 9/18-19, 10am-4pm: 20-Year Celebration. Chalk Art @ Streets @ South-Glenn, a pancake breakfast, a car show, live music, family activities, vendors & food.
- Sat., 10/23, 3-7pm: Whiskey Warmer @ Park.
- Sat., 12/4,11am-4pm: Holiday Artisan Market @ the Park
- The City is again doing a Community Survey. Surveys have been mailed to 3,000 random citizens but, anyone take it, here.
- Centennial Active Seniors are starting up again.
- There are 4 Neighborhood Traffic Mitigation Projects selected for this year. For more info on the projects, check here.
- The City will be soon starting the <u>Smoky Hill Transportation Corridor Study</u>. Its
 purpose is to enhance safety in crossings, enhance medians for refuges (cross the
 road half way) but, probably, the road won't be widened, depends on the study.
- Arapahoe Bridge replacement has gone out to bid.
- The City is updating its <u>Transportation Master Plan</u>. Watch the website for info.
- The new <u>Intelligent Transportation System</u> will be operating by the end of 2021, to make Yosemite corridor more responsive to current situations.
- The City Council had a strategic planning session on the finances of City. There will be more.
- Manning: Are grant funds still available? Piko: I have to say, yes, there's probably more availability for the \$500 grants.
- Hamilton: What about the City finances? Piko: We came out of COVID much better than anticipated, only down about \$8M. Total Wine was a boon and IKEA did well.
- City will receive \$8M from ARPA funds, \$4M this year and \$4M next year.
- SB217 had unintended consequences for the Sheriff's Office. They had to hire 17
 IT people to handle the data required to be kept from body worn cameras. Coresponders has been an excellent program: mental health professionals are cal-led
 out when it's determined that a deputy isn't needed. ACSO has been contract-ing
 for the service but will be bringing it in house.
- A new design was created for the intersection of S. Havana St. & E. Easter Ave.
 but, there was no funding for it. Federal money has just been announced to help pay for it.
- Noon: Many splash pad features aren't operating. Mayor: It could be a parts problems. The City is also replacing some dead trees.
- 3. Centennial Code Compliance, Tamara Gregory, Code Compliance Manager (absent)
 - The Mayor made a few comments.
 - Some codes have been put in place to deal with dangerous, empty houses, unkept-up.
 - The City has hired one code compliance officer for commercial properties.
- 4. Plans, Rhonda Livingston, Vice President
 - · No new plans at this time

- On 7/19, the City Council will have a hearing on drive-thru restaurants on the University corridor. They don't require an inside dining room and right now are limited to 7 (more?).
- Lambert (Tiffany): It could be OK if they're less obvious & nicer looking.
- Suhaka suggested that there shouldn't be any allowed in the King Soopers center opposite the high school due to extreme danger to the high school students.
- Meakins: This could open up the possibility of many more around the City.
- Mataich: Make sure none are too close to homes.
- Noon: The more we fight commercial, we could just get apartments. Most commercial center plans allow for some residential.
- Suhaka: I'm concerned that should University plans go forward, what will happen to the Smoky Hill Corridor.
- Streets @ SouthGlenn proposed residential
 - Noon: The utilities in the SG area weren't built for that kind of density.
 - The SouthGlenn Master Development Plan has a list of criteria that must apply, refer to the list. Suhaka: I could find nothing about SouthGlenn on the City website
- 5. Adjourn: Livingston adjourned the meeting at 8:58pm.



Directions from the Library Admin. Building/ACSO HQ would be:

- EB on Broncos Pkwy to S. Potomac St.
- SB on Potomac to S. Potomac St. (if you continue straight it turns into Chambers Rd.) turn right at the light
- SB on Potomac St. (turns into County Line Rd) to S. Peoria St. (south of Centennial Airport
- SB on Peoria St. to Aviator Way
- WB on Aviator Way to Double Helix Court
- NB on Double Helix Ct to UMFCL last building on the left



If you have an E470 pass,

- Take E470 to Peoria St.,
- Turn north on Peoria to Aviator Wy
- Turn west on Aviator to Double Helix Ct.
- Turn north on Double Helix to the building
