Resolution R-2013-09

A RESOLUTION AUTHORIZING THE MAYOR TO USE ROAD IMPROVEMENT BOND FUNDS FOR THE PROVISION OF LANDSCAPING ALONG STATE ROUTE 125.

WHEREAS, Amelia Village has excess funds in the Road Improvement Bond Fund and landscaping is a permissible use of these funds; and

WHEREAS, the use of the Road Improvement Bond Funds for landscaping would improve the aesthetics along the State Route 125 corridor;

NOW THEREFORE, BE IT RESOLVED THAT:

SECTION I. The Council of Amelia Village, Ohio, authorizes the Mayor to procure landscaping for property owned by the Village on the north side of State Route 125 in an amount not to exceed ten thousand dollars (\$10,000.00).

SECTION III. Council hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of the Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

CHRIS DICKERSON moved to suspend the rules requiring three readings on three separate dates.

DERRICK CAMPBELL seconded the motion.


