## Bloomfield Police Department Monthly Report for January 2018

This is the monthly report for the Month of January 2018 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

During the month of January the police department received one theft from automobile complaint where the vehicle had been left unlocked. I would like to take this opportunity to remind everyone to remove valuable items and lock your vehicles when left unattended/parked. Almost all of the theft from motor vehicle complaints reported to the police department involved vehicles which had been left unlocked.

On Wednesday, January 3<sup>rd</sup> at approximately 2:54pm officers responded to a residence in the 1300 block of Thistle Road for a residential fire. The fire was ultimately extinguished by the Bloomfield-Genoa City Fire Department assisted by other area fire departments. The residence was severely damaged by the smoke/fire and there were not any injuries reported.

On Friday, January 5<sup>th</sup> at approximately 10:30pm officers executed a traffic stop on Hwy 50 for a speeding violation. At the conclusion of the traffic stop a 27-year-old female was arrested for operating a motor vehicle while intoxicated 1<sup>st</sup> offense. Additionally, the female was issued traffic citations for the speeding violation and operating a motor vehicle without insurance.

On Sunday, January 7<sup>th</sup> at approximately 9:45pm officers received a physical abuse of a child complaint. At the conclusion of the investigation a 39-year-old female was arrested. A charge of child abuse – intentionally cause harm was forwarded to the Walworth County District Attorney's office.

On Monday, January 8<sup>th</sup> at approximately 12:33pm officers responded to the area of Hwy H and White Pigeon Road for a personal injury crash. At the conclusion of the investigation an 88-year-old male was issued a traffic citation for unreasonable/imprudent speed.

On Thursday, January  $11^{\rm th}$  at approximately 9:30am officers responded to a residence in the 900 block of Juneau Road for a theft from motor vehicle complaint. The complainant reported person(s) unknown entered the **unlocked vehicle** and stole an envelope containing money. This incident remains under investigation.

On Saturday, January 13th at approximately 10:15pm officers attempted to execute traffic stop for a speed violation in the area of Hwy 120 and Hwy H. The vehicle operator refused to stop at which time a small pursuit ensued until the fleeing vehicle crashed in the area of Hwy H and Lake Geneva Hwy. The 22-year-old male driver was arrested without further incident for fleeing/eluding a traffic officer and an extraditable warrant from Illinois then confined in the Walworth County Jail. A charge of fleeing/eluding a traffic officer has been forwarded to the Walworth County District Attorney's office. Additionally, the driver was issued traffic citations for speeding, reckless driving, operating without a valid driver's license and unreasonable/imprudent speed. There were not any injuries reported as a result of the crash and the fleeing vehicle sustained moderate damage.

On Wednesday, January  $17^{th}$  at approximately 7:15am officers responded to a residence under construction on Luscombe Lane for a theft complaint. A contractor reported that person(s) unknown had gained entry into a locked trailer at the work site taking numerous tools. This incident remains under investigation.

On Monday, January 29<sup>th</sup> at approximately 12:09am officers responded to a residence on Juneau Road for a loud music/noise complaint. It was determined that officers had been to the same residence earlier in the day for the same complaint. At the conclusion of the incident a 30-year-old female was issued a non-traffic citation for loud/unnecessary noise.

During the month of January 2018 officers from the Bloomfield Police Department affected 7 arrests for warrants issued by the Bloomfield Municipal Court satisfying approximately \$5,122.00 in outstanding forfeitures.

During the month of January 2018 the Bloomfield Police Department responded to 930 calls for service compared to 720 calls for service during the month of January 2017. During the month of January 2018 the police department affected 116 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 86 arrests during the month of January 2017.
