- o (roughly 30% of lots in Silver Sands)




### Respondent Demographics Questions #1 - #4

o Others are Renters or Non-Titled Spouse/Dep.






### 57/37/6 Split on If Council Should Get More Info




Are You A Full-Tim... V



### Q3 Are You A Full-Time/Permanent Resident (Live In The Municipality 6+ Months Of The Year), or Seasonal/Part-Time?





### Q4 Do You Own or Rent Property in the Summer Village of Silver Sands?



Just as an example, as a Summer village, we are not required to have a council, therefore the question is unfortunately obvious, how much does council currently cost our Summer Village, and could this cost be avoided by no longer having a council to govern the summer village? Has the disbandment of council been investigated or surveyed as much as this potential change to a Village from Summer Village? What are the actual tangible, measurable impacts of having a council as a Summer Village, to residents and land owners, both positive and negative.
