- FORMAT: 36-hole, two person team (team score is one best ball of the two players)
- ENTRY FEE: \$210 per player (\$420 per team) includes 2 rounds of golf with cart, range balls, awards luncheon & prizes.
- TIME: 9:00 AM shotgun start both days
- FIELD: Limited to the first 60 paid team entries
- COMPETITORS: All players must be a member in good standing of WSNGA or NNGA with a verifiable handicap
- HANDICAP: Maximum handicap is 36. Each player will receive 95% of her course handicap. If a difference of more than 8 strokes cannot be avoided an additional 10% reduction will be applied to the course handicap of each member of the advantaged side. (USGA handicapping guidelines)
- REQUIREMENTS: Soft spikes are mandatory. With the exception of the 2010 groove rule, non-conforming clubs are not allowed. Caddies are not permitted.
- AWARDS: Prizes will be awarded for gross and net finishes – at least 1/3 of the field will be paid
- ENTRIES: **Deadline to enter is February 21, 2018.** No refunds will be given after that date. Incomplete entries will be considered void and not accepted.
- Course Setup: The course will be played at 5399. Please go to www.nevadawomensgolf.org for exact hole yardages.
- CHECK IN: There will be no check-in either day.
- AWARDS/LUNCH: At the luncheon immediately after play on Tuesday
- PRACTICE ROUND: Practice rounds may be booked directly through the Revere Golf Club.
