THE GRANT AND ITS PURPOSE

- The grant will enable at least \$1.25 million to be expensed on improving the lives of our congregations and communities across Virginia over a period of five (5) years.
- The grant is designed to create a new space for congregations to reflect on who they are in today's POST-COVID religious environment in rethinking
- 250 congregations will participate within cohorts over the grant period.
- 50 congregations will be eligible to receive a share of the \$75,000 grant to address community and congregational needs.
- The grant will be housed at the BGCVA Headquarters, namely Suite 2. There will be upgrades for improving communications of needs of congregations across Virginia back to the office of BGCVA and a greater ability to dispatch resources, partnerships, and capacity building.
- Communication and technology upgrades of Suite 2 will assist BGCVA in centralizing this new point of service.
- *The grant will enhance ministries to support some of the ongoing work of BGCVA.



THE CURRICULUM AND PROGRAM DESIGN

- Curriculum
 - How the congregation connects with God?
 - How the congregation connects with each other?
 - How the congregation connects with community?
- Program Design
 - Churches apply to be part of the regional cohort churches
 - Churches journey together as regional cohorts through the three (3) modules
 - First Year of 2024: June October; Subsequent Years of 2025 2028: May September
 - BGCVA assesses the needs of congregations (individually, regionally, and statewide) at the onset and throughout the process
 - BGCVA will build, develop, and employ "wraparound services" to begin addressing and meeting the identified needs
 - BGCVA will determine the efficacy of the program through pre-program and post-program evaluations




THE COHORT MODEL

- We grow together!
- Each regional cohort is composed of 10 churches per region per year
- Cohorts engage the material together and learn to work together as a regional community that continues to grow year by year




THE REGIONALIZATION




- Current regional separation

THE REGIONALIZATION




- Planned Regionalization for Lilly Grant
 - Aligning as close to Area Model
 - Consideration national regional alignment
 - Balance of numbers to ensure 50 churches in a region is not more than 35% of the number of churches in the region






THE REGIONALIZATION — THE CENTRAL REGION



- Cities: Colonial Heights, Hopewell, Petersburg, and Richmond






THE REGIONALIZATION — THE EASTERN REGION






THE REGIONALIZATION — THE NORTHERN REGION



- Cities: Alexandria, Fairfax, Falls Church, Fredericksburg, Manassas, Manassas Park, and Winchester






THE REGIONALIZATION — THE SOUTHERN REGION

THE REGIONALIZATION — THE WESTERN REGION



THE CHURCH LEARNING GRANTS

- Allows churches to focus their energies on a particular community outreach program
- Grants are of \$1,500 per church on a yearly basis for 10 churches per year, divided evenly across the regions
- This is a combination of churches that are and are not in that year's cohort churches.
