

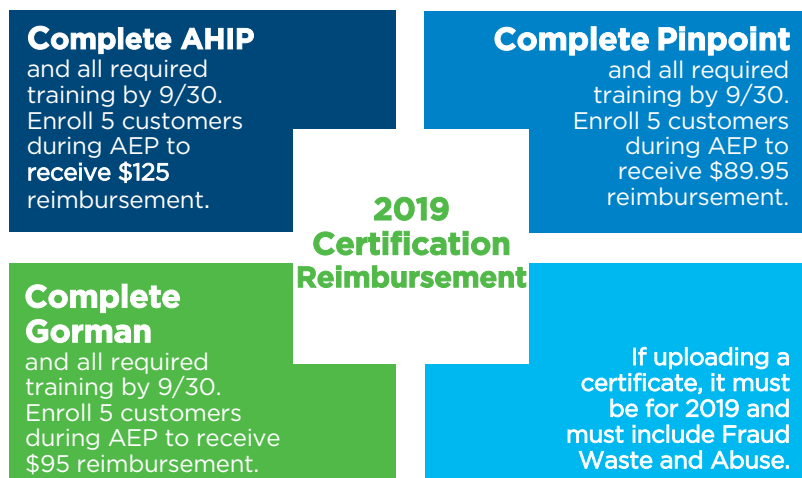
Your Roadmap to 2019 Certification.

Cigna-HealthSpring

Path to Certification

- Complete ALL necessary paperwork
- Head over to Cigna-HealthSpring Producers' University at <https://cignahealthspringproducers.com> and complete all the required training on your track
- Pass each course with a score of at least 85%. You have 3 attempts to pass
- External Agents have a choice of launching and completing AHIP or Pinpoint Medicare Training from the Producers' University. They may also upload a 2018 certificate from AHIP, Pinpoint or Gorman Health
- Internal agents can only take the Pinpoint Medicare Training
- The Attestation course contains 3 separate attestations: Policies, Rules of Engagement and Social Media
- In addition to the AHIP, Pinpoint or Gorman Health Medicare Training/Certificate, all agents and agencies must complete the required Cigna-HealthSpring training on their assigned track
