Town of Dix Regular Board Meeting October 9, 2023

Supervisor Smith opened the Public Hearing regarding the PUD at 1889 Meads Hill Road at 5:30 PM followed by the Pledge of Allegiance. RESOLVED, that based upon completion and review of the Environmental Assessment Forms pertaining thereto, the Town Board finds that the amendment of section XV-6(c) of the Town of Dix zoning code presented herrewith will result in no significant adverse environmental impact; and

RESOLVED, that the Town od Fix Town Board hereby adopts Local law #2 of 2023 which amends section XV-6(c) of the Town of Dix Zoning Code as follows:

Section SV-6(C) is amended and restated in its entirety as follows:

Following receipt of the recommendation of the Planning Board the Town Board may by local law adopt an amendment to this chapter creating a Planned Unit Development District. The local law may include a schedule for phased development if phased is contemplated as part of the planned unit development, and shall provide that the existence of the Planned Unit Development District is

conditioned upon site plan, subdivision and special use permit review and approval by the Planning Board, as applicable to the comtemplated planned unit development for the entire development or the first phase of development if a phased development is contemplated.

WHEREAS, the Town of Dix is a participant in the Greater Tompkins County Municipal Health Insurance Consortium (the "Consortium"), a municipal cooperative organized under Article 47 of the New York Insurance Law, and

WHEREAS, the municipal participants in the Consortium, including this body, have approved and executed a certain Municipal Cooperation Agreement (the "Agreement", effective date of October 1, 2010), and

WHEREAS, Article 47 of the New York Insurance law (the "Insurance Law") and the rules and regulations of the New York State Department of Financial Services set forth certain requirement for governance of municipal cooperatives that offer self-insured municipal cooperative health insurance plans that requiers any amendments or restatements thereto, shall be subject to Board review and upon acceptance of any new Participant hereafter, and

WHEREAS, the Municipal Cooperative Agreement requires that amendments to the agreement be presented to each participant for review and adopted by a majority vote by its municipal board, and

WHEREAS, the Town of Dix is in receipt of the proposed amended Agerement and has determined that it is in the best interest of its constituents who are served by the Consortium to amend the Agreement as set forth in the Amended Municipal Cooperative Agreement, now therefore be it

RESOLVED, that upon receipt and review of the amended Agreement, the Town of Dix approeves at a meeting of the governing body held on October 9, 2023 and authorizes the Chief Elected Official to sign he 2023 Amendment to the Municipal Cooperative Agreement of the Greater Tompkins County Municipal Health Insurance Consortium as recommended by the Board of Directors.
