MAC01/2024 Chairman's Welcome and Remarks:

It is resolved that Cllrs Bolt, Tolson & Roberts are appointed for MTC, D Horrobin & Cllr S Guy appointed for RBL, H Baker for the Faith community and committee to approach others to join the committee including an independent.

- The quorum for the meeting will be 4, of which one must be a RBL rep and one a Councillor. Notes of the meetings will be kept and circulated for note by the Council via the Clerk - Resolved

MAC07/2024 <u>Mirfield Remembrance Parade 2024:</u>

1. To discuss the Mirfield Remembrance Parade 2024 and agree any actions or costs necessary – Cllr Bolt reports that he is approaching Traffic Management companies to provide quotations for the parade, Sect 8 qualified person must initiate all road closures and there should be 2 weeks' notice advertised for any road closures. Clerk clarifies that MTC PL Insurance can only be used for events that MTC organise, therefore the parade must be organised by MTC for PL Indemnity. Clerk also confirms that any meeting of MTC be it Full Council or a Committee of council cannot be held in licensed premises or premises serving alcohol, if possible, the room to be FOC if not a minimal charge. D Horrobin confirms that RBL do not organise parades as it is a Civil event this is organised by the local Town/Parish or Municipal councils. Clerk confirms item 4 of the Terms of Reference regarding finance and the allocated budget for the committee. Cllr Naisbett states that the committee must consider Martyn's Law and he will arrange for Kirklees to attend a future meeting of MAC. Cllr Bolt states that the committee need to be vigilant with security & traffic management.
