The meeting notice was sent out by email on September 1, 2016.

Beth read the minutes from the last quarterly board meeting. Ryan motioned to accept the minutes as read. Katy K seconded the motion. All agreed.

Katy K. read the financials. To date, all homeowners have paid their yearly dues. The current balance is \$12,136.05.

Various Board members asked clarifying questions about the written financial report. Kendall brought up that it looks like we actually budget more than we bring in each year. Total money we bring in from dues currently is \$7775.00. (While it was mentioned that most of the developer's lots are either sold or under contract, that was not the case when we developed and approved the 2016-2017 budget.) The current budget is for \$8775.00. After we looked at current spending and past trends, we determined we are trending only \$450.00 above the current budget. So, it was noted we need to watch the spending for the remaining fiscal year.

Kendall motioned to approve the financial report. Beth seconded the motion. All agreed.

Landscaping Report:

Ryan said that Cutting Edge has been doing a good job overall. They have been lax on removing weeds, but they catch up the next time they mow. Beth brought up the bushes that we voted on adding in the back of the fence. Ryan explained how he and Jonathan Cook decided to wait until we decide what to do about the wall. If it is shortened, the bushes will be added after completion of the fence if needed. If it is not shortened, they will be added as previously approved.

Welcome Committee Report:

Beth explained that she is ready to deliver Welcome packets to the two homes who have new homeowners. She went on to mention that she knows several lots have sold and/or under contract. She'd like to give each owner a Welcome packet upon ownership of the lot, once it is verified the new owner plans to build and take occupancy of the home on
