Bloomfield Police Department Monthly Report for March 2018

This is the monthly report for the Month of March 2018 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

Follow Up On Friday, June 23, 2017 officers had responded to a report of a vehicle fire on Rose Drive in the Nippersink Subdivision. On June 30, 2017 this incident was reclassified from assist fire department to an arson investigation after new information had been reported. On or about March 7th this case has been closed. Charges of arson of property other than building and bail jumping – felony have been forwarded to the Walworth County District Attorney's office for a 22-year-old male.

On Thursday, March 1st at approximately 9:10pm officers executed a traffic stop on Hwy 50 in the area of Eastside Road for a traffic violation. At the conclusion of the traffic stop a 35-year-old male driver was issued traffic citations for exceeding zone & posted limits and operating after suspension.

On Sunday, March 4th at approximately 7:32pm officers responded to the Pell Lake Mobil for a reckless or possibly intoxicated driver complaint. At the conclusion of the investigation three counts of misdemeanor bail jumping were forwarded to the Walworth County District Attorney's office for a 38-year-old male. Additionally the male subject was issued a non-traffic citation for resisting/obstructing a police officer.

On Saturday, March 10th at approximately 7:08am officers responded to Pioneer Estates located at N2020 Hwy H for a hit & run property damage only crash. At the conclusion of the investigation a 72-year-old female driver was issued traffic citations for hit & run – unattended motor vehicle and failure to notify police of an accident.

On Sunday March 11th at approximately 1:59am officers executed a traffic stop on Pell Lake Drive in the area of Hwy U for a traffic violation. At the conclusion of the traffic stop a 30-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the male was issued traffic citations for failure/improper stop at a stop sign and operating a motor vehicle with a prohibited alcohol concentration.

On Monday, March 12th at approximately 10:08am officers responded to a residence on Lincoln Drive for a domestic abuse complaint. At the conclusion of the investigation charges of criminal damage to property and disorderly conduct were forwarded to the Walworth County District Attorney's office.

On Monday, March 19th at approximately 8:20pm officers executed a traffic stop on Nippersink Road in the area of Powers Lake Road for a traffic violation. At the conclusion of the traffic stop a 19-year-old male driver was issued traffic citations for exceeding zone & posted limits and operating after suspension.

On Thursday, March 22nd at approximately 9:44am officers responded to a residence on Mulberry Road for a domestic abuse complaint. At the conclusion of the investigation a 41-year-old male was arrested and confined in the Walworth County Jail. Charges of battery, disorderly conduct and strangulation/suffocation have been forwarded to the Walworth County District Attorney's office.

On Friday, March 23rd at approximately 6:47pm officers executed a traffic stop on Hwy U in the area of Eastside Road for a traffic violation. At the conclusion of the traffic stop a 21-year-old female was issued traffic citations for non-registration of a motor vehicle and operating after suspension.

On Saturday, March 24th at approximately 10:11pm officers executed a traffic stop on Hwy 50 in the area of Eastside Road. At the conclusion of the traffic stop a 20-year-old male driver was issued traffic citations for exceeding zone & posted limits and operating after suspension.

On Saturday, March 31st at approximately 2:00am while on patrol officers observed a person known to be on probation/parole inside a tavern. At the conclusion of the investigation a 41-year-old female was arrested and confined in the Walworth County Jail for violation of her probation/parole.

During the month of March 2018 officers from the Bloomfield Police Department affected 11 arrests for warrants issued by the Bloomfield Municipal Court satisfying approximately \$1608.00 in outstanding forfeitures.

During the month of March 2018 the Bloomfield Police Department responded to 1,183 calls for service compared to 743 calls for service during the month of March 2017. During the month of March 2018 the police department affected 246 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 96 arrests during the month of March 2017.
