## Waiver and Release of Liability - Fun Shoot & ELR

I \_\_\_\_\_, the undersigned person, request to voluntarily participate in the 2018 Fun Shoot and ELR Event held at Corbett Farms in Louisiana. In consideration of the permission granted by the landowner and South Central Shooters Club and affiliated event organizers to participate in the events, I for myself and anyone accompanying myself, I hereby:

1. Release, discharge and covenant not to sue Bryan McCann, his heirs or assigns, of SCSC's officers, agents, staff, personal, or event organizers (all hereinafter collectively referred to as the "Releases") from any and all claims, liabilities, causes of action, ordinary negligence of Releases or any other participant which causes the undersigned injury, death, damages, or property damage. I hereby covenant to hold Releases harmless and indemnify Releases for any claims, actions, suits, complaints, procedures, costs, expenses, judgements, damages and liabilities or expense Releases may incur arising out of, or connected with my activities or participation in the competition or club activity, or presence at the firing range or area of the events.

2. Understand that my entry into this Fun Shoot/ELR Competition and/or participation therein, and my entry upon any premises where this fun shoot and competition is held, that there is a DANGER AND RISK OF INJURY OR DEATH. In addition, I understand that the present condition and activities of the competition may change and may become more hazardous and dangerous and that there is INHERENT DANGER in said Competition, which I appreciate and voluntarily assume. I have observed and am aware of these types of events and the risk involved. I understand that I am responsible for any dangers caused by my equipment, ammunition, or use of these. I understand that other participants in these events pose a danger to myself and that I have no control over these other persons. I voluntarily accept to accept risks connected with participation in the fun shoot and ELR Competition.

3. Acknowledge that I am aware of generally accepted gun safety and regulations and been advised of the rules of the fun shoot and ELR competition and my responsibilities during the match and have complied with each said rule, regulation, and responsibility. If I have failed to do so, or if I fail so to do I assume risk for myself and assume all liability to others for such failures and I hereby release all parties and releases for any failure in inspecting any equipment. No oral representations, statements or promises have been made to me to induce me to sign this agreement. If any portion of this agreement is held invalid, it is agreed that the balance thereof shall continue in full legal force and effect.

4. Agree that this agreement shall apply to any accident, injury, cause of action, incident or death occurring at or arising out of the above-mentioned fun shoot and ELR competition or activity.

5. Agree that I am fully aware that I am attending a live fire fun shoot and ELR competition and therefore understand the risk and inherent danger of the possibly of injury and/or death. I am over the age of eighteen (18) and fully understand all the terms, conditions, and representations herein.

6. Understand that if any legal action is taken or brought under this agreement, the prevailing party shall be entitled to recover from the other party, reasonable attorney fees whether or not a suit is filed.

7. Agree that this agreement shall be governed by and construed in accordance with the laws of the state of Texas

The South Central Shooters Club (SCSC) has been organized under the guidelines & rules established by the Fifty Caliber Shooter's Assn., Inc. (FCSA) and uses those guidelines in the promotion of long distance shooting competition.

It should be noted that membership in the FCSA and the SCSC is a required for participation in a 'Sanctioned' fifty caliber competition conducted by South Central Shooters Club . Participation in a "Fun Shoot" sponsored by SCSC does not require membership in FCSA. However we encourage support of the FCSA thru membership by all .50 BMG shooters.

The SCSC membership fees are \$45 per person for two years or \$65 for three years.

Membership fees are due January 1st of each calendar year.
