## NOTICE TO ALL EXHIBITORS

All dogs six (6) months and older must have an individual ASCA registration, LEP number or an ASCA QTracker number to compete in ASCA sanctioned Obedience/Rally Trials. A dog will be allowed to be shown at the trial where the handler applies for an ASCA tracking number. No dog without an ASCA individual registration, LEP number or ASCA QTracker number may compete in any ASCA Obedience/Rally Trial. Photo copies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned Obedience/Rally Trials. Each non-ASCA registered dog will be required to have an ASCA Tracking Number. There is a one-time fee of \$10/ dog. At the time of applying for the tracking number, the individual owner must also be an ASCA member (minimum membership type of Service is required). ASCA membership does not need to be maintained in subsequent years. If your dog does NOT have a tracking number, you can get the form by following this link. <https://www.asca.org/wp-content/uploads/2016/04/trackapp.pdf>. Then include that form and check or Money Order payable to ASCA with your entry. Forms will also be available at the trial. **Bitches in heat will not be allowed to compete.**

### Trial hours are 7:00am until 7:00pm

The ring will be located outdoors on grass. We recommend that you bring sun and wind protection.

***No day of show set ups are allowed on the show lawn until 7:00 a.m. Saturday in order to allow for the show committee to set up for the show. Roping off or "pre-reserving" of day set up spots will not be allowed prior to 7:00am on Saturday.*** Delta ASC will be hosting Conformation shows also, so *please do not set up too close to the conformation ring(s).* ***Grounds open at 7 am and close at 10pm.***

### DIRECTIONS TO STANISLAUS COUNTY FAIRGROUNDS: 900 N Broadway, Turlock, CA

**From North:** Take Hwy 99 South to Turlock. Exit Fulkerth, turn left (eastbound). The third stop light will be Golden State. Make a right on Golden State and then an immediate right on to North Front. Go approximately 2 blocks and make a right, cross the RR tracks, right on Broadway and enter through back gate.

**From South:** Take Hwy 99 North to Turlock. Exit Fulkerth, turn right (eastbound). Follow above directions.

**From the Bay Area:** Hwy 580 to 205 East towards Tracy/Stockton. Take I5 North and merge onto CA 120 towards Manteca/Sonora. Exit at Hwy 99 South (Modesto) and continue to Turlock.
