

RESOLUTION NO. 2010-1

**RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE
OF INNSBROOK TO APPLY FOR PARTICIPATION IN THE
NATIONAL FLOODPLAIN INSURANCE PROGRAM (NFIP).**

WHEREAS, certain areas of the Village of Innsbrook are subject to periodic flooding causing serious damages to properties within these areas; and

WHEREAS, relief is available in the form of federally subsidized flood insurance as authorized by the National Flood Insurance Act of 1968; and

WHEREAS, it is the intent of this Board of Trustees to require recognition and evaluation of flood hazards in all official actions relating to land use in areas having these hazards; and

WHEREAS, this body has the legal authority to adopt land use and control measures to reduce future flood losses pursuant to RSMO 80.090

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE VILLAGE OF INNSBROOK, MISSOURI, TO HEREBY:

SECTION I. Assure to the Federal Insurance Administration that it will enact as necessary, and maintain in force in those areas having flood hazards, adequate land use and control measures with effective enforcement provisions consistent with the criteria set forth in Section 60.3 of the National Flood Insurance Program (NFIP) regulations; and

SECTION II. Vest the Administrator of the Village of Innsbrook with the responsibility, authority and means to:

- a) Assist the Federal Insurance Administrator, at his/her request, in delineating the limits of the areas having special flood hazards;
- b) Provide such information as the Administrator may request concerning present uses and occupancy of the floodplain areas;
- c) Cooperate with federal, state and local agencies and private firms which undertake to study, survey, map and identify floodplain areas, and cooperate with neighboring communities and the county with respect to management of adjoining floodplain areas in order to prevent aggravation of existing hazards;
- d) When received from the Administrator, complete and submit those reports to the Administrator concerning the community's participation in the NFIP including, but not limited to the development and implementation of floodplain management regulations; and
- e) Upon occurrence, notify the Administrator in writing, whenever the boundaries of the community have been modified by annexation or loss of authority to adopt and enforce floodplain management regulations for a particular area. Included in such notification will be a map of the community, suitable for reproduction, which clearly

delineates the new corporate limits or new area for which the community has assumed or relinquished floodplain management regulatory authority.

SECTION III. Appoints the Village of Innsbrook Administrator to maintain for public inspection and to furnish upon request, for the determination of applicable flood insurance risk premium rates within all areas having special flood hazards identified on a FHBM or FIRM, any certificates of floodproofing and information on the elevation (in relation to mean sea level) of the lowest floor (including basement) of all new or substantially improved structures, and include whether or not such structures contain a basement, and if the structure has been floodproofed, the elevation (in relation to mean sea level) to which the structure was floodproofed; and

SECTION IV. Agrees to recognize and duly evaluate flood hazards in all official actions in the areas having special flood hazards and to take such other official action as may be reasonably necessary to carry out the objective of the Program.
