9	Mayor Roecks called the meeting to order at 7:01pm with the Pledge of Allegiance.

11	Roll call took place. Those present were Mayor Carrie Roecks, Councilmembers Micki Harnois, Tim,
12	Fricke, William Benson, Brian Laude, Clerk/Treasurer Heidi Johnson and Public Works' Dave
13	Thompson.
14	
15	Ms. Harnois made a motion to excuse Councilmember Clint Stevenson. Mr. Laude seconded the
16	motion. Motion was carried.
17	
18	Mr. Benson made a motion to approve the amended agenda. Mr. Fricke seconded the motion.
19	Motion was carried.

21	Mr. Benson made a motion to approve the minutes from the 04/04/2018 regular meeting, with a
22	correction to line 15, changing Mr. Harnois to Ms. Harnois. Mr. Fricke seconded the motion. Ms.
23	Harnois asked that line 43, change the word "nominate" to "suggest." Motion was carried.

20 29	Ms. Roecks welcomed Resident Ivan Willmschen back home from his winter in Arizona. She also
30	welcomed Representative Joe Schmick to the council meeting. Rep. Schmick said he was glad to be in
31	Rockford to hear of the challenges the town could be facing and that he has been trying to attend a
32	council meeting in all of the local towns.

34	COUNCIL REPORTS
35	Ms. Harnois attend an Infrastructure Workshop in Moses Lake. She met with Cynthia Wall from the
36	Department of Ecology, who stated that she has been in contact with the Riverkeepers regarding
37	Rockford. Ms. Wall said that she feels her meeting with the RiverKeepers was a positive one.

39	Ms. Harnois mentioned that there is a Small Cities Connectors meeting in Palouse, WA on May 29 th .

42	Planning and Zoning
43	Ms. Harnois said that she spoke a realtor who owns a lot on East Lake Street. He had questions about
44	subdivisions and road widths and she was able to help him out.

46	Comprehensive Plan
47	Ms. Harnois said that she will have the determination of non-significance, which is an environmental
48	determination, ready by Friday. Mr. Benson stated how thankful and lucky is that Rockford has
49	someone with Ms. Harnois' knowledge. She said she will schedule a public hearing for the DNS mid-
50	May. There will also need to be a special meeting held with Council to discuss the zoning regulations.

51 COMMITTEE REPORTS 52 Finance Committee 53 Met on 04/11/2018 to discuss the Lagoon Fund and the potential purchase of a dump truck. 54 55 Asset Management Committee Will schedule a meeting soon. 56 57 58 Water/Sewer/Streets 59 Mr. Thompson mentioned that St Joseph's Catholic Church has asked if the town would be willing to 60 help with replacing the sidewalk by the church, since half of it is on the town's right-of-way. It was the consensus from the council that the town could do the work if St Joseph's paid for the material. 61 62 63 Improvement Board 64 Council wants to get the ball rolling in getting the abandoned house on 106 E A Street boarded up. Mrs. 65 Johnson will send a letter to the owner. 66 67 Tree City/Parks 68 Ms. Harnois stated that she left a message for Garth Davis with the Conservation District and has not 69 received a call back yet. 70 71 PUBLIC COMMENT 72 Lorrie Engle asked if the town could charge the owner of the 106 E A Street house for the material to 73 board it up. She also said that Melissa's Lids will be giving away free helmets again at the Frog Regatta 74 on April 28th. 75 76 Mr. Fricke asked Rep. Schmick about what could be done regarding nuisance/abandon properties. He asked for some direction on what other municipalities have had success with. Rep. Schmick said he 77 78 would look into it and get back with Mr. Fricke. 79 80 ORDINANCES/RESOLUTIONS 81 Mr. Benson made a motion to approve Resolution 18-02, declaring certain real estate surplus. Mr. Fricke seconded the motion. Motion was carried. 82 83 84 **OLD BUSINESS** 85 None 86 87 **NEW BUSINESS** 88 None 89 90 PUBLIC COMMENT 91 Resident Vicki Bergstrom asked Rep. Schmick if there was recently a bill that passed about abandon 92 buildinas. 93 94 Resident Ivan Willmschen asked where the surplus property was located. He also asked when he could 95 get some clarification the checks that are on the register. 96 97 STAFF REPORTS 98 Public Works 99 Mr. Thompson wants to set up a meeting with all the property owners involved with getting a water and sewer line extended to East B Street. There was discussion on a vault being put in at 100 101 East Lake Street.

- Mr. Thompson told council that the new bagger was purchased and installed on the mower.
- It was reported that Union Pacific Railroad granted the town an easement for the sewer line
 work through Rock Creek, and that it would cost \$3000. Mr. Thompson has completed the
 JARPA form and sent it to Layne Merritt, JUB Engineers, for review. He now needs to complete
 the SEPA checklist.
- Ms. Roecks told council that the finance committee had met to discuss purchasing a dump • truck. There was discussion on the options the town could use to purchase the dump truck. Mr. Fricke made a motion to allow the Clerk/Treasurer, Heidi Johnson, and Public Works Director, Dave Thompson to find and purchase a dump truck, using \$15,000 of the towns available funds and for Mrs. Johnson to obtain a loan for the remainder of the cost, not to exceed \$30,000 for the entire purchase, and with the best interest rate possible. Mr. Fricke included that the \$15,000 of the towns available money be taken out as follows: \$5000 from Current Expense, and \$2500 each from Water, Sewer, Streets and the Equipment Reserve. Mr. Laude seconded the motion. Motion was carried.
 - Mr. Thompson mentioned that Public Works is updating all the cross-connection information and will be sending a survey out to the residents in May.
- 119 Clerk/Deputy Clerk
 - Mrs. Johnson submitted the proposed budget amendments for the first quarter. Council discussed some of the changes and decided to wait to approve them until the next meeting.
- Resident Ivan Willmschen asked council if the town needs to get competitive bids for the dump truck
 purchase. He also asked for some clarification on the checks that were to be approved.
