Mr. Boo commented he has been a long-time resident of LaGrange, expressed his dissatisfaction about the amount of money that has spent to date on the D204 litigation and asked when it is expected to be resolved. Review School Districts Official Records

Board of School Trustees discussion and review of the Lyons Township Schools and Coop’s financial records for May 2020. Treasurer Getty noted that the May 2020 financial statements for D102 remain outstanding.

NEW BUSINESS:

Lyons Township Municipal Liquidity Facility

This program was first discussed at the June 22, 2020 TTO Board meeting and is being developed proactively to assist our member districts and other agencies within Lyons Township during these unprecedented times. Occasionally, in the past, and as allowed by the investment policy, the TTO has invested in tax anticipation warrants, bonds and other municipal instruments. This program would provide direct lending of cash from the TTO’s liquid short-term investment portfolio to other local government agencies. Direct lending could potentially reduce local government’s cost of borrowing and increase the TTO’s return on the funds as compared to other short-term investments vehicles. Treasurer Getty noted that this program is allowable under the TTO’s Investment Policy, specifically, Article 5 of the policy. He further reminded the Trustees that the TTO’s Investment policy is available on the office’s website and that this policy is in line with the allowable investments defined in the State of Illinois Public Funds Investment Act and the State of Illinois Investment of Municipal Funds Act.

OLD BUSINESS:

Pro-Rata Receivables - FY2019

Treasurer Getty provided an update on the FY2019 Pro-rata receivables. All payments have been received, except for Districts 204, 217 and LADSE.

Cook County Tax Distribution – FY2021

Brigid Murphy, Director of Finance & Operations updated the Trustees on the second installment property tax distributions.

District 204 Litigation Update

Due to the Covid-19 pandemic the Circuit Court of Cook County has put a hold on all civil litigation proceedings. A new trial date has not yet been set. All filings are current and available on the TTO’s public website. The Trustees remain willing to participate in settlement discussions.





The Trustees discussed Argo Summit Community High School District 217, and the Treasurer's Contract – July 1, 2020 to June 30, 2021.


5. Adjournment.
