About Us

Rebuilding Together New Britain is a registered nonprofit organization that assists low-income New Britain homeowners, specifically the elderly, disabled, and families with children, with critical home maintenance and repairs that they are unable to manage on their own due to physical and/or financial limitations. RTNB's goal is to ensure these homeowners continue to live in comfort, warmth and safety in their own homes.

Our Programs

We operate our services year-round through programs that match individual volunteers, small teams, or large groups to address as many repairs and home improvements as we have the technical expertise and financial resources to complete. We are able to consider most repair requests, however, Rebuilding Together New Britain does not offer emergency repair services, foundation stabilization, and certain major plumbing (such as a new side sewer system) or major electrical (such as panel upgrades or whole house rewiring) work.

Basic Criteria

To be considered for our programs, homeowners must meet the following criteria:

- ✓ You must be the legal property owner and the home must be located in New Britain
- ✓ You must currently live in the home and plan to remain living in the home for at least the next <u>3 years</u>
- ✓ You must be low-income and reasonably unable to complete the work on your own

Required Documents: Please attach complete copies of EACH the following verification documents to your application.

- ✓ Income Verification—Acceptable verification includes your most recent tax return and copies of benefits or other income statements (Ex. Social Security, pay stubs, unemployment, pension, etc.)
- ✓ Asset Verification—Acceptable verification includes most recent monthly statements for all checking and savings accounts, annuity amounts, and proof of other real estate, if applicable. (Ex. Bank statements, annuity documents, deeds, etc.)

*There is no fee required to apply to receive assistance from Rebuilding Together. Rebuilding Together has not authorized any other person or entity to act as its agent for purposes of this application and any fees or costs associated with this application paid by the applicant to any person or entity are not fees or costs charged by Rebuilding Together.
