AMANA NEWS AND NOTES

Heritage Society Announces Cap Campaign

The Amana Heritage Society has launched a campaign to fund three very important projects for the nonprofit which maintains and manages the Amana Heritage Museum and associated historical sites in our seven villages.

The nonprofit group is working to raise money

- Homestead Village Church Museum \$120,000. Critical restoration/ repairs to the interior of the 1865 church, install HVAC and upgrade electrical systems so that the building, located in the heart of Homestead, may be stabilized and used year-round. Adding climate controls and new electrical wiring will make it structurally more safe and secure, while making it usable for performances, events and educational programs.
- Restoration of the Middle Amana Cooper Shop - \$9,000. One of the last remaining craft shops and the only cooper shop in the seven villages, this in-tact structure should be stabilized so that it can be seen and appreciated. As a part of the Middle Amana Ruedy Kitchen house complex it shows visitors communal village life. The goal is to make it an "active interpretive space that showcases one the most documented trades in Amana communal life."
- Digitization of historic films, videos and audio recordings - \$2,700. The Amana Heritage Museum has over 900 fragile films, videos and audio recordings, including oral histories. Some of these are decades old. The work to preserve these for the future has been ongoing with grants, in-kind donations and gifts helping to complete an estimated \$25,000 in media preservation work. This final \$2,700 will be used to match grants received and complete the project to digitize.

"Each of these projects plays a vital role in preserving Amana's history and keeping it accessible, meaningful and alive," stated Jon Childers, Amana Heritage Society executive director.

Simply put, basic repairs are needed to save the Homestead Church.

"It's crucial for the future of the building," Childers said.

The list of repairs is long, but includes getting a new furnace – the one in place does not work. It also includes repairing floors, windows and doing repairs and clean up in the basement. All of this is just to get the building up to a basic level.

The Community Foundation of Northeast Iowa, the Iowa County Community Foundation grant of \$12,000 announced last week is a help. Every dollar will be put to good use as it will pay for about half of the HVAC install, Childers noted.

However it will take a total of \$120,000 to make the needed repairs, install new wiring, a new furnace and an air conditioning system at the Homestead Church.

The goal is to make the church as functional as possible while maintaining its character and its story as the village spiritual center. The village church is Homestead's historic heart and soul and to be able to use it – first as a site open to the public, secondly as a space to experience history, and finally as a place to experience lowa and Amana-focused performances and classes would be a huge win for the Amanas.

In future the Amana Heritage Society would like to be able to host lectures and performances, like the one woman show on a German immigrant's experience in lowa held this summer in the Homestead Welfare Club.

Furthermore, upgrades will allow the museum curator, Rebecca Simpson and staff, to create exhibits to interpret and share what's in the building or was once in the building.

Aging floors and windows damaged over time, high humidity and a non working furnace, meant that church cannot be used in winter. Some areas of the building can not be used at all. Books and historical objects can be kept in the church. With the repairs and the installation of HVAC, the church will be able to be open more and offer more space to exhibit and interpret its artifacts and books. Events at the church, from lectures to zither concerts, may help pay the costs of keeping it open while teaching and promoting Amana and lowa heritage, Childers explained.

"We are so pleased to begin work on the Homestead Village Church Museum as a part of our strategic goals to elevate awareness and appreciation for Amana heritage. On 30 days marketing, we were able to draw over 80 people to a performance (in Homestead this past summer). We're looking forward to cooperating with TKM Theatrical Productions, Janet Schlapkohl, and zither player, Ann Prinz, to activate the Homestead Village Church Museum as a unique performance venue and elevated interpretive site," Childers said.

Similarly at the Cooper Shop in Middle Amana basic work needs to be done to stabilize and repair the building. So far \$8,000 has been raised of the \$17,000 needed so the Board of Directors and museum staff hope to raise the needed \$9,000 to make repairs and to catalog and interpret the 250 tools and objects associated with communal barrel-making – plus create hands-on educational exhibits. The goal is to fully utilize the site and share its rich history with visitors. Because it's just steps away from the communal kitchen the cooper shop adds to a villagescape of communal life making this site doubly important, Childers explained.
