Due Dates:

- Real Estate Taxes paid in full are due by January 31, 2021. If taxes are paid in installments, the <u>first</u> installment is due to the <u>Village by January 31, 2021.</u>
- <u>Second</u> installment is due to the **Columbia County Treasurer's Office** by July 31, 2021 (address is on the tax bill). Please DO NOT send your second installment to the Village of Pardeeville, this will delay the payment process and could result in interest and penalty.
- All Personal Property Taxes must be paid in full by January 31, 2021 to the Village of Pardeeville.

Payments:

- Payments may be mailed to the Village of Pardeeville at P.O. Box 217, Pardeeville, WI 53954.
- Payments postmarked on or before December 31, 2020; or dropped off before start of business on January 4, 2021; will be receipted for 2020.
- Payments may be made in person by appointment only; however, we recommend mailing your payment or putting the payment in our utility payment drop box at the Village Office, 114 Lake Street. ALL PAYMENTS MADE THROUGH THE DROP BOX AND MAIL WILL BE MAILED A RECEIPT.
- Please <u>DO NOT</u> include any dog/cat license fees in your check for paying taxes. These <u>MUST</u> be separate.
- OFFICE HOURS: Monday through Friday, 7:30 a.m. 4:00 p.m; doors are locked due to health emergency so you must call upon arrival for assistance. Our office will be closed for the holidays on December 24 & 25th and December 31st and January 1st.

Dog & Cat Licenses:

- The limit on pets is 3 dogs <u>or</u> 3 cats <u>or</u> no more than 4 dogs and cats residing in one residence per Village Ordinance.
- If you no longer have a pet that was previously licensed please contact us so we can remove them from the pet licensing system (failure to license will generate a letter).
- You may mail or drop off or mail your rabies certificates with payment (must include date of vaccination, serial #, manufacturer and tag #).
- Licenses <u>NOT</u> obtained by April I, 2021, will be subject to a late fee and possible citation from the Columbia County Sheriff's Department! Citation for an unlicensed pet is \$218.50

You are able to drop off your rabies certificates and payment (or call and check to see if they are needed) and tags/certificates will be mailed back to you.

Winter parking rules

Winter parking rules are in effect from <u>November 15th to April 1st</u> between 1:00 a.m. and 6:00 a.m. Park cars on the odd or even side of the road that corresponds to the day from 1 a.m. to 6 a.m. (Example at 1 a.m. on the 16th you would need to be parked on the even side of the road.) IF YOU ARE A LANDLORD PLEASE NOTIFY YOUR TENANTS!

Snow emergency parking in addition to alternate side parking!

A snow emergency is AUTOMATICALLY declared when a snow is forecasted to be 3" or more during any period of 24 hours or less. Under a snow emergency ALL vehicles must be OFF the streets until they have been plowed. We will enforce our ordinance 32-155.

Snow Removal

Don't forget that you must clear the snow/ice from your sidewalk within 24 hours after the snow has stopped. **Snow/ice should not be pushed or blown onto the street.**

If there is a fire hydrant in the right-of-way on your property, please remove the snow around it. This is for your safety and the safety of your neighbors in case of a fire emergency this winter.
