## **Water & Sewer/Streets & Alley Report – Derek Keutzer**

- Flushing hydrants

- Ordered a bunch of new signs (speed limit, truck routes etc.)

- Had to replace a generator at the main lift station.
- Salt will be \$74 per ton this year.
