High School Plus:

Alies Muskin gave update on High School Plus and concerns that need to be addressed. MCCPTA should make comments at BOE meeting on May 21 related to concerns raised. Einstein HS, Rockville HS and Wheaton HS are piloting High School Plus. This is offered right after school day. MCPS wants to move ahead with placing this in all 25 schools in Fall of 2007 without all data gathered to show that High School Plus is effective. MCPS has budgeted \$460,000 in FY08 for High School Plus.

Junior Achievement Meeting:

Sharon Schulman gave brief update on Junior Achievement meeting that she and Jane de Winter attended.

CIP:

CIP Comments are due June 1. CIP Cluster Comment Workshop will be on May 16th in cafeteria at Carver.

Grading and Reporting:

Beth Kennington gave an update on Grading and Reporting developments. Beth sent out an email about the standards based reports cards and implementation holdup. Summer homework packets were discussed and language drafted by Grading and Reporting Implementation Team (GRIT). GRIT also discussed academic dishonesty. Flow chart was produced and will go out to locals. MCPS is drafting language for MCPS Regulation- IKA-RA.

EPI:

Vicki Rafel, Bylaws Chair provided information about EPI and says board members are needed.

New Business:

Wootton Cluster concerns about a teacher being arrested from one of their middle schools and PTAs being asked to give statements to press. Locals want to know how to handle this. Suggestions are given.
