## 2021 DELKER DUNES FACILITY RULES AND REGULATIONS

- 1) Each player will need to bring their own beach volleyball to each day of each session and each tournament. They will only use their volleyball. If a player is with a partner, they can share a volleyball. We will wipe down volleyballs often.
- 2) Each player with bring their own sanitizing wipes and/or sanitizer to wipe down their volleyballs during each clinic session and each tournament.
- 3) Each player will bring their own water bottle and only use their own water bottle for clinics and tournaments.
- 4) Each player **will take their temperature** at home before they come to each day of each session. Players will stay home that day if they have any temperature other than normal. This applies to tournaments as well.
- 5) If the player is ill or if anyone in the household of the player is ill that player will not attend beach clinic or tournaments for that week.
- 6) If a player has been around anyone outside of their household that is ill, that player will not attend the clinic or tournaments for that week.
- 7) If any player tests positive for COVID-19 and has been in any of my clinics or tournaments, report it to us immediately so that we can let the other families know.
- 8) If a player tests positive for COVID-19, they will not be allowed to participate in my beach program until they are fever and symptom free and cleared by a doctor.
- 9) If a player is directly exposed to someone who tests positive for COVID-19, they will not be able to attend clinics until they have tested negative for COVID.
- 10) If a player loses sense of taste or smell they will not attend clinic until they have been tested for COVID-19.
- 11) Players are not to high five, hug or touch another player in celebration during clinics or tournaments.
- 12) 6 foot of social distancing will be in effect during clinics and tournaments when not in play.
- 13) Players WILL wear masks at all times at Delker Dunes. We will need a note if a medical situation restricts a player from wearing a mask.
- 14) Players, parents and spectators will NOT be allowed to mingle in the barn this year. Please bring appropriate gear for all kinds of weather.
- 15) ABSOLUTELY NO PETS ALLOWED IN YOUR CARS ON THE THOMPSON'S PROPERTY. You will be asked to leave the property and retrieve your player at the mailbox by the main road.

\*\*\*We have the right to send any player home from participation in clinics and/or tournaments if we feel that payer does not fit the criteria that we had set forth.

\*I have not been diagnosed with the Coronavirus/COVID-19 and not yet cleared as non contagious by state or local public health authorities.

\*I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.
