

We, the undersigned natural persons of the age of twenty-one (21) years or more, at least two of whom are sitizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is NORTHSHIRE MAINTENANCE FUND, INC.

The corporation is a non-profit corporation.


ARTICLE III
