## Santa Fest & Christmas Parade



Tampa's Christmas Parade will roll out in on Saturday, December 7, at 11 a.m. This year's parade is the largest Christmas Parade ever held with 95 colorful units. There will be beads, candy and other goodies tossed to onlookers as the floats, Krewes, dance groups, and others take part in this much anticipated annual event.

The parade begins at Madison and Pierce streets. Heads west on Madison Street then turns north onto Ashley Drive, and ends at Curtis Hixon Waterfront Park. The best viewing area is along Madison Street from Pierce Street to Tampa Street.

Parade viewers are encouraged to arrive by 9 a.m. to avoid road closure and to get a good spot along the parade route. Suggested parking options:

- Jackson Street, E. Kennedy Blvd & Jackson Street
- Ft. Brooke Garage, 107 N. Franklin Street

After the parade, the fun continues in Curtis Hixon Waterfront Park with 38th Annual Santa Fest. Bring your little elves to Santa Fest for a free keepsake photo with Santa sponsored by the Friends of Tampa Recreation; continuous holiday entertainment, interactive games, bounce houses, a rock wall, and make-n-take crafts. The festival continues until 4 p.m.

An attitude of gratitude is always obvious. If we are grateful for what God has done for us and given to us, others will see our appreciation of it in everything we do. David gave us a fourfold formula to follow.

"I will thank You Lord, with all my heart." The *thanksgiving* he describes is total and consumes all of his being - his entire self. The word he used for *heart* would include his consciousness of God's presence, his memory of God's goodness and his awareness of God's grace. He worshiped God with excitement, enthusiasm and expectation.

"I will tell all of the *marvelous* things You have done." *Marvelous* comes from a word that means "extraordinary, not to be surpassed by anyone and wonderful!" He is so overwhelmed by God's blessings on his life that he wants *everyone* to hear about it.

"I will be *filled* with *joy*!" Joy is the natural state of the one who trusts in the Lord. Knowing that "all things work together for our good" should cause His joy to radiate from our hearts into our heads and out through our hands. Everything we do should be done with a smile on our face and gladness in our eyes.

"I will *sing* praises to Your Name, O Most High." Notice that there is only one letter different between the word "sin" and "sing" - the letter "g" - that stands for God. When we give up sin for the Savior, God gives us a new song to sing. It is a song about *the* Savior who loves us, gave Himself for us, is present in us and cares for us.

Thanksgiving

Not long ago a student came into my office and asked, "Dr. Guido, will you do a favor for me?"

Without knowing what favor the student wanted, it was obvious that I had a certain amount of power over him and could do something for him that he could not do for himself. He literally was at my mercy.

Moses concluded Psalm 90 with a gracious reminder of God's power and our need to work for His favor. "May the favor of the Lord our God rest upon us," he wrote. And then he described how we *could* know that God's favor was on our work: God Himself would *establish* the work of our hands. "Establish the work of our hands for us - yes, establish the work of our hands." When Moses added the "for us" he underlined the fact that God Himself is the one who established our work, not us. Whatever we do is temporary. Whatever God does through us is eternal.

How, then, can we work with God to *establish* works that are eternal? Paul gives us a clear answer: "Stand firm. Let nothing disturb you. Always give yourselves fully to the work of the Lord because you know that your labor in the Lord is not in vain."

But just what is "the work of the Lord?" we ask.

Jesus answered that: "Love the Lord Your God with all your heart - and love your neighbor as yourself." And "who is my neighbor" someone asked? His answer: "Anyone who has a spiritual, emotional or physical need."

It is difficult to go from one place to another without seeing someone who has some need. Our *work*? Meet it.

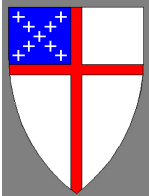

True Thanksgiving

So, what is Thanksgiving? The simple version a time when people come together and celebrate all the things that they are thankful for and eat lots of good food. So much food that sometimes we have to sleep the rest of the day to recoup! And don't forget about the football. That is another tradition that started long after the first Thanksgiving.

Well the holiday has evolved into this, but when did it really start and why? The story goes that Thanksgiving happened in October 1621 at Plymouth Plantation in Massachusetts where William Bradford and other settlers landed on their way to the New World. Once they got established and had a harvest, they celebrated with a feast lasting three days, which was attended by the Pilgrims and Native Americans. The feast included foods like; waterfowl, venison, ham, lobster, clams, berries, fruit, pumpkin, and squash, all the kinds of foods that encompassed what the Native Americans had and what the settlers brought and harvested.

However, the Florida Humanities Council and other Florida historians believe it was very different. Not that they don't believe Plymouth happened, but they believe that 56 years prior to the traditional date, Thanksgiving was celebrated in our great state of Florida. In or around September 1565, when Spanish Admiral Don Pedro Menendez de Aviles landed in St. Augustine, Florida with 500 soldiers, 200 sailors, and 100 civilian farmers and craftsmen, they claimed La Florida on behalf of Spanish monarch Phillip II. They were greeted peacefully by members of the Timucua tribe. Because it was a Spanish tradition was to celebrate safe arrivals, they did so by having a Mass of Thanksgiving, the very first Catholic mass on American soil, and they invited the Timucua tribe for a feast. This is where the first Thanksgiving really came from. There is more to the story than just that. Historians also claim that the food was much different. From what they know about the food provisions stocked on Menendez's ships, the meal that they shared would have had food like; salted pork and garbanzo beans laced with garlic seasoning and accompanied by hard sea biscuits and red wine. Since the Timucua were guests they would have contributed to the brought foods like; local game and fish, grains, corn, beans, and squash all a part of the Florida agriculture. Nothing like the Thanksgiving we know today.

Believe it or not, that is not the only Thanksgiving that Florida hosted. It has also been determined that there was another Florida Thanksgiving in 1564. French explorer Rene Goulaine de Laudonniere called for a feast to celebrate the establishment of Fort Caroline atop St. Johns Bluff, near present-day Jacksonville. He, too, crossed paths with the Timucua Indians who warmly welcomed the French Huguenots and prepared a feast in their honor. So this must be the first Thanksgiving year (1564). You have to remember that many people arrived on the East coast of Florida and the Timucua Indians were always very welcoming. We have to believe that Juan Ponce de Leon, in 1513 and 1521, Panfilo de Narvaez in 1528, Hernando de Soto in 1529, Father Luis Cancer de Barbastro in 1549, and Tristan de Luna 1559 and all might have crossed paths with the Timucua Indians who welcomed everyone with a feast. So, we might not really know the date of the first Thanksgiving, but we do know that all of them were celebrated with thanks and appreciation. So let's keep eating that turkey and being thankful for all we have.

Broccoli is in season during Thanksgiving, so give this recipe a try:

BARELY-BLANCHED BROCCOLI SALAD WITH FETA AND FRIED ALMONDS

yield: 4 SERVINGS  
total time: 23 MINUTES  
prep time: 20 MINUTES  
cook time: 3 MINUTES  
INGREDIENTS:

- 1 tsp. + 1/4 tsp. salt (I used kosher salt)
- 1 lb. broccoli crowns, trimmed and cut into same-size florets
- 1 large clove of garlic
- 2 T red wine vinegar
- generous pinch hot pepper flakes (I used Aleppo pepper; see note.)
- 1 T + 4 T extra-virgin olive oil
- 1/2 cup slivered almonds
- 1/2 – 3/4 cup crumbled Feta cheese

DIRECTIONS:

1. Fill a medium-sized pot with water, add 1 tsp. salt, and bring to a boil. While the water is heating, trim the broccoli crowns and cut into bite-sized flowerets. (Make them all the same size so they will cook the same amount.) When water is boiling, add the broccoli, cook for exactly 3 minutes, then drain broccoli into a colander placed in the sink and let it cool.

2. Mash the garlic with 1/4 tsp. salt. (I used a mortar and pestle, but you can use anything that will smash up the garlic.) Mix in the hot pepper flakes and red wine vinegar and let it sit for about 10 minutes.

3. Heat 1 T of olive oil in a heavy frying pan, add the almonds, and fry until they are lightly browned, about 2-3 minutes. (Watch carefully because they can go from lightly browned to burned rather quickly.) Put the almonds on a plate covered with a paper towel and let almonds cool a few minutes. (You can salt them if you want, but I thought the salad was salty enough with the Feta.)

4. After 10 minutes, whisk the remaining 4 T of olive oil into the vinegar-garlic mixture. Combine the broccoli, Feta, and half the almonds in a bowl; then toss with the dressing to coat. Serve salad right away, with remaining almonds sprinkled over the top.

Art of José Tornès Featured in Franciscan Center Stress Less Shopping Experience



Seldom offered in the United States, paintings by acclaimed Cuban artist José Carlos Jerez Tornès are available through silent auction bidding at the Franciscan Center's Stress Less Open House, Tuesday, Dec. 3, 5 to 8 pm.

The six paintings are oil on canvas and range in size from 20 by 12 to 22 by 30 inches. Subjects include colorful rural Cuban scenes: horses galloping, a vibrant rooster, a flowering tropical tree, a young girl by a window. All of the paintings have been legally imported from Cuba by José Remon of the Tampa Bay area. Remon is a long-time sponsor of Tornès.

The artist was born in Manzanillo, Cuba on June 23, 1987. He studied painting and drawing at the Professional Academy of Plastic Arts "Carlos Enriquez Gomez" of Manzanillo from 2002 to 2006. Tornès' career was interrupted by an 18-month period of "Mandatory Military Service" after which he resumed his artistic endeavors as an Instructor Professor at La Casa Cultura de Manzanillo in Cuba.

Remon supports the painter by supplying him with paint, canvas and wood for frames. Due to government restrictions, these items are very difficult to obtain in Cuba. Remon is careful to follow all the proper channels in bringing the artwork to the United States. He then donates them as fundraisers to various non-profit organizations, including the Franciscan Center. Due to his efforts and those of other sponsors, Tornès' work can be found internationally in over seven countries.

The paintings will be on display with silent auction bids taken from 5 to 8 p.m., Dec. 3, at the Franciscan Center, 3010 N. Perry Ave., Tampa, FL 33603.



### Four Places to View Florida's Fantastic Flocks

Warm weather and ample food bring migratory birds our way beginning in autumn

*Snowbirds aren't the only visitors to Hillsborough County.*



Migratory species - the kind with feathers and wings - take advantage of the area's moderate temperatures and plentiful food. Flocks take to the air each fall, and Hillsborough County parks and preserves are great places to see them.

When it begins getting cooler up North, warblers, goldfinches, American robins, and white pelicans are among birds finding temporary refuge along Tampa Bay's coasts and in the county's interior. Enthusiasts and casual observers are likely to spot birds often associated with places hundreds of miles away.

Last year's fall-winter-spring migration was particularly large.

Here are four Hillsborough County locations where migratory birds are prevalent, and a few of the well-travelled species you might see there:

**Lettuce Lake Conservation Park:** This 240-acre tract east of the University of South Florida campus is Hillsborough County's most popular park. Bird-watching is a favorite activity, and wintertime migrations offer some of the best viewing. Look for various warblers, hermit thrushes, Eastern phoebes, catbirds, and belted kingfishers, among other species.

**Cockroach Bay Preserve:** A series of mangrove islands dot Tampa Bay's shallow southeastern coast, from the mouth of the Little Manatee River southward. In winter months you might see peregrine falcons, merlins, American kestrels, yellow-breasted chats, and white pelicans.

**Upper Tampa Bay Conservation Park:** Look for Carolina chickadees, belted kingfishers, hermit thrushes, pied-billed grebes, and various migrating ducks.

**Edward Medard Conservation Park:** You might see cedar waxwings, bobolinks, ruby-crowned kinglets, American robins, and warblers (palm, pine, yellow-rumped, and orange-crowned).

Not sure where to go or what birds you might see? Guided tours are available. See the Tampa Audubon Society web site for field trips, or check out the Hillsborough County events calendar.

Whether you're a devoted ornithologist or a casual bird-watcher, it's a fine time to be outdoors, looking skyward. Migratory birds provide a once-a-year viewing experience for Hillsborough County residents, and a slice of home for those other snowbirds, our human friends from other regions of the country and nations.

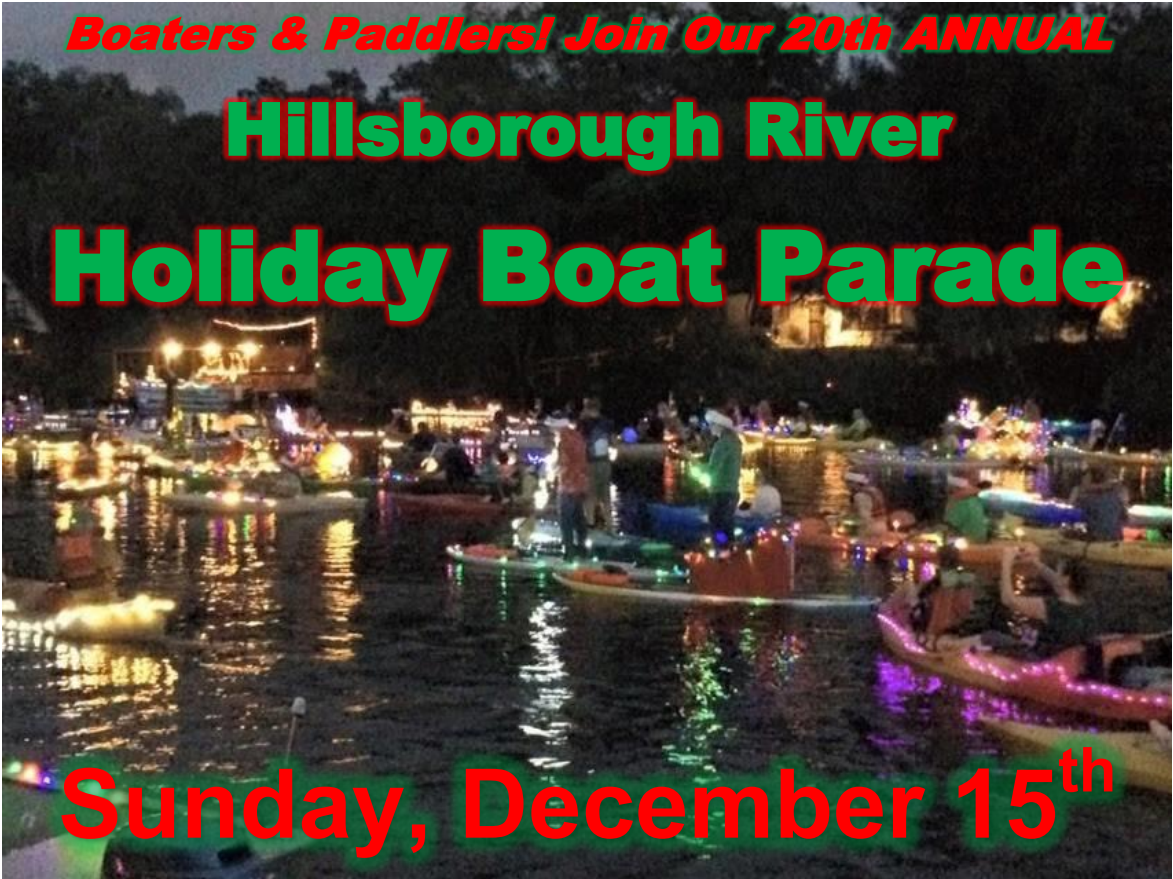
