An Ordinance Appropriating certain Money's.
Be it ordained by the Mayor and Commissioners of the city of Garnett
Kansas.

Section One:- that the sum of *Two Hundred and Twenty Eight and*
7/1000000 Dollars be and the same is hereby appropriated
out of the General Funds in the hands of the city Treasurer to pay the
Bills allowed against said Funds at a regular meeting of said Board held
on the 5th day of October 1914. a list of which may be found on page *178* of
the Journal of the proceedings of the Board on said date.

Section Two:- that the sum of *Three Hundred and Ninety One and*
78/1000000 Dollars be and the same is appropriated out
of the Water Works Funds in the hands of the city treasurer to pay the
Bills allowed against said Funds at a regular meeting of said Board
held on the 5th day of October 1914. a list of which may be found on
page *178* of the Journal of the proceedings of the Board on said date.

Section Three:- that the sum of *One Hundred and Sixty Five and*
27/1000000 Dollars be and the same is hereby appropriated
out of the Street Funds in the hands of the city treasurer to pay the Bills
allowed against said funds at a regular meeting of said Board held on the
5th day of October 1914. a list of which may be found on page *179* of the
Journal of the proceedings of the Board on said date.

Section Four:- that the sum of *Fifty One and 2/1000000*
0000000 Dollars be and the same is hereby appropriated
out of the Cemetery Funds in the hands of the city Treasurer to pay the
Bills allowed against said funds at a regular meeting of said Board
held on the 5th day of October 1914. a list of which may be found on
page *178* of the Journal of the proceedings of the Board on said date.

Section Five:- that the sum of *One and 7/1000000*
0000000 Dollars be and the same is hereby appropriated
out of the funds, Sewer District number (2) in the hands of the city
Treasurer to pay the Bills allowed against said funds at a regular Meeting
of said Board held on the 5th day of October 1914. a list of which may
be found on page *178* of the Journal of the proceedings of the Board
on said date.

Section Six:- that the sum of *One Hundred and Thirty Three and*
65/1000000 Dollars be and the same is hereby appropriated
out of the Water works Extension Bond funds, in the hands of the city
Treasurer to pay the bills allowed against said funds at a regular meeting
of said Board held on the 5th day of October 1914. a list of which
may be found on page *177* of the Journal of the proceedings of the Board
on said date.
