CALL TO ORDER

The meeting was called to order at 7:00 P.M. by Hansen, followed by the Pledge of Allegiance and prayer.

APPROVAL OF MINUTES

Cannon moved, supported by Pitcher, to approve the July 8, 2019 Minutes. Motion carried.

TREASURER/FINANCIAL REPORTS (on file)

Hansen noted corrections that need to be made to the Treasurer Report. Pitcher stated that she would make those corrections and bring the corrected report to the September meeting.

ZONING ADMINISTRATOR REPORT (on file)

Buchholz's report is on file. There was one zoning permit and no Land Division Application during the month of July. Buchholz reported mixed results on the blight letters that he had sent out. The Board encouraged Buchholz to be more aggressive in pursuing compliance to the Township blight ordinance. Buchholz will be turning the Petersheim blight problem over to the Township attorney this month. Mr. and Mrs. Phillips were in attendance at the meeting and requested clarification on what needs to be done to comply with the Township blight ordinance. Buchholz supplied the Phillips with a copy of the blight ordinance and fence setback requirements.

ROAD REPORT

Cannon reported that Lake Road has been graveled, Backus was finished today, and that roads are rough and need rain before grading can be completed.

FIRE REPORT

Burr reported that Maple Valley Fire Department desires to join the Lakeview Fire District. Updates on the process will be reported as progress is made.

CEMETERY REPORT

There was no written report this month, but Shindorf turned in monies for two cremain burials.

Hansen presented a bid from Paul Howell amounting to \$4183.04 for installation of an exit door on the Township Hall. Burr moved, supported by Sprague, to accept this bid.

Roll Call Vote - Pitcher - Yes; Hansen - Yes; Cannon - Yes; Burr - Yes; Sprague - Yes. Motion carried.

Hansen presented a bid from Dan Petersheim in the amount of \$1,450.00 for cement and installation of sidewalk cement from the above new door to the parking lot. Pitcher moved, supported by Cannon, to accept this bid.

Roll Call Vote - Hansen - Yes; Cannon - Yes; Burr - Yes; Sprague - Yes; Pitcher - Yes. Motion carried.

Hansen presented a bid from Henry Petersheim in the amount of \$5,590.00 for materials and installation of a new steel roof on the Township Hall. After discussion, Burr moved, supported by Pitcher, to table action on this bid until the September meeting. Motion carried.

NEW BUSINESS

SUPERVISOR REPORT

Hansen reported the need of weeding to be done around the Township Hall building and road sign. Pitcher reported that Pitcher Perfect Excavating charges \$40.00 per hour for labor and \$40.00 per gallon of Roundup. Sprague moved, supported by Hansen, to authorize Pitcher Perfect Excavating to complete this project. Motion carried.

PLANNING COMMISSION RECOMMENDATION

The Planning Commission held a public hearing on July 29, 2019 regarding a special land use permit request for the purpose of building a school at 6395 Cannonsville Road, Lakeview and recommended that the Board approve the permit.

Pitcher moved, supported by Cannon, to accept the Planning Commission recommendation.

FIRE DISTRICT PAYMENT

Pitcher moved, supported by Burr, to authorize payment of the semi-annual payment to the Lakeview Fire District in the amount of \$30,438.50. Motion carried.

Sprague reported that the local chapter MTA meeting would be held on Tuesday, August 20, 2019 at the Eureka Township Hall. Hansen, Cannon, and Sprague will attend.
