### PUBLIC NOTICE FOR THE OPENING AND CLOSING OF THE HCV WAITING LIST

# THE DANIA BEACH HOUSING AUTHORITY WILL BE ACCEPTING PRE-APPLICATIONS FOR THESECTION 8 HOUSING CHOICE VOUCHER (HCV) WAITING LIST

Preliminary applications must be completed online Tuesday, March 21<sup>st</sup>, 2023 at 9:00 a.m. EST through Wednesday, March 22<sup>nd</sup>, 9:00 a.m. EST. The system will automatically close on March 22<sup>nd</sup> 2023 at 9:00 a.m. EST. After the preliminary application window is closed, the system will do a random lottery selection of five hundred (500) of the pre-applications to move to the Dania Beach Housing Authority HCV waiting list.

To be eligible to be placed in the waiting list, the Head of the Household <u>MUST</u> be 18 years of age or older. The total household annual gross income <u>must not</u> exceed the *low-income* limitsfor the appropriate family size as listed on the Income Limits Table appearing at the end of this Public Notice.

If you wish to apply, you will need to logon to <a href="https://daniabeach.housingmanager.com/">https://daniabeach.housingmanager.com/</a> and press the APPLYING FOR HOUSING button on the landing page. Please ensure that you complete <a href="https://daniabeach.housingmanager.com/">all</a> the required fields, or the application will not successfully be submitted at the end.

## Pre-Applications WILL BE ACCEPTED ONLINE <u>ONLY</u>.

Pre-Applications must be completed beginning

Tuesday March 21<sup>st</sup>, 2023 at 9:00 am EST until the system closes the window automatically on Wednesday, March 22<sup>nd</sup>, 2023 at 9:00 a.m. EST. The system will then randomly select five hundred (500) pre-applications lottery style to be added to the Dania Beach Housing Authority waiting list.

Hand delivered or Mailed applications WILL NOT be accepted.

#### For the HCV Waiting List:

The waiting list application will randomly by lottery style pick five hundred (500) completed pre-applications submitted online these will be added to the waiting list. If you successfully are added to the waiting list and have any changes to address, phone number, income, or any other information, you must log back into the application and **EDIT** the application by entering the new information. Please record your pre-application ID.

- > Placement on the waiting list will be determined by the order the system randomly selects the pre-applications for the list from the submission of the completed on-line pre-applications.
- > Duplicated applications will be removed.
- Incomplete applications will not be submitted.
