

AMELIA VILLAGE, OHIO
Ordinance O- 2015-39

AN ORDINANCE BY THE COUNCIL OF AMELIA VILLAGE FOR THE
PURPOSE OF INCREASING THE MONTHLY SALARY OF MEMBERS
OF VILLAGE COUNCIL AND THE VICE MAYOR EFFECTIVE
JANUARY 1, 2016 AND REPEALING ORDINANCE NO. 2007-68.

WHEREAS, Members of Village Council have not had a salary increase since 2007;

NOW, THEREFORE, be it ordained by Council of Amelia Village, Clermont County, Ohio,
that:

SECTION I. That effective January 1, 2016, the salary of members of Village Council, whose
term of office begins on or after January 1, 2016, shall be Three hundred Sixty dollars ⁶⁷/₁₀₀ dollars
(\$ 316.⁶⁷) per month, to be paid in monthly installments for each month or part thereof
which the member of Village Council holds such office.

SECTION II. That effective January 1, 2016, the salary of the Vice-Mayor (Mayor Pro-
Tempore), shall be Three hundred Eighty three ³²/₁₀₀ dollars (\$ 383.³²) per month, to be paid in
monthly installments for each month or part thereof which Vice-Mayor holds such office.

SECTION III. That Ordinance No. 2007-68 is hereby repealed effective January 1, 2016 as to
members of Village Council whose term of office begins on or after January 1, 2016.

SECTION IV. This ordinance shall take effect and be in force at the earliest time allowed by
law.

SECTION V. Village Council hereby finds and determines that all formal actions relative to the
passage of this ordinance were taken in an open meeting of this Council, and that all
deliberations of this Council and of its committees, if any, which resulted in formal action, were
taken in meetings open to the public, in full compliance with applicable legal requirements,
including Section 121.22 of the Ohio Revised Code.

Mrs. Gerber moved to suspend the rules requiring three readings on three separate dates.

Mrs. Dickerson seconded the motion.
