



The organizers of the **7th Annual “Stir the Pot: Louisiana Seafood Cook-off and Festival”** have schedule this year’s event for **April 22, 2017** from 11 a.m. to 5 p.m. In addition to the food prepared by our cook-off teams, silent and live auctions and live music by **The Beau Young Band** this year’s event will incorporate a vendor component. We’re trying something new. Registration is open to all vendors or craftsmen and will NOT be restricted to ‘nature related’. **NO FOOD or BEVERAGE vendors will be allowed.**

Vendors: A \$50 registration fee will apply. Fee entitles vendor to 10 X 10 space. Vendors will be able to sell, promote and demonstrate at their space. In an effort to decrease competition and give you the opportunity to showcase your products, only 1 vendor will be allowed to display/sell the same items. (*1 vendors selling handmade furniture, 1 selling Native plants, 1 bird houses, etc.*). ALL vendors (*selling items*) are required to fill out and return **both** the attached festival and Office of State Parks registration forms (*disregard the \$75 vendor fee on this form*). Vendors are responsible for compliance with any applicable state or sales tax requirements that may apply. Vendors will be allowed to request set up between the cook off teams in the cook off area (*more a.m. traffic*) or the stage side of the event (*more p.m. traffic*). Your location request will be considered and approved according to space available and items offered. Vendors are responsible for compliance with all permits and taxes that apply to them.

Demonstrators: No registration applies. Promotions and demonstrations only, no sales. Non-profits are welcome to set up and promote their passion. Demonstrators will be set up in the grassy area between the parking lot and splash pad or in the stage side of the event. Duplicate demonstrators will not be allowed. Demonstrators are only required to fill out the festival registration form.

The festival does not supply tents and tables. No electricity or water connections will be available at sites. *Small ‘quite’ generators are acceptable.* Space set up will be allowed between 7 a.m. and 10 a.m. All vehicles must be removed from the festival by 10 a.m. and will be allowed back in to festival area at 5 p.m.

Free Advertising! Vendors/Demonstrators who provide pictures or logos via email will be promoted via Facebook and Newsletter. The sooner you provide information the more exposure you’re likely to get.

Campsites available! A **LIMITED** number of campsites are available for **REGISTERED** vendors & demonstrators on a first come, first serve basis. Only 1 campsite may be requested. The cost is **\$56** per site for Friday & Saturday nights. Payment is must be sent with your registration.

Submit completed registration forms and fees to reserve your space by **April 1, 2017**.
