"Came to believe that a power greater than ourselves could restore us to sanity."

He said: when I first saw this step I did not understand what it was asking me to do. I saw it as so many others do, when they first see it. I thought it said that I had to believe in a Power greater than myself to be restored to sanity. There were two problems with this; first I believed that God was going to roast and toast me for the way I had been living and second I did not think that I was insane, just bad. This line of thinking was quickly corrected by a sponsor who pointed out what the step actually said, followed by the guestion "How would I explain the way I had been living for so many years?" In the beginning of my sobriety it was necessary for me to believe in the AA group as a power greater than myself to allow me to see the insanity of my lifestyle. Listening to others share their experience allowed me to identify with the many ludicrous and outlandish schemes that I employed to stay drunk and outside the realm of reality. As I began to grow in sobriety and start taking the steps and utilizing them in my everyday life I began to see the extent to which I was living insanely. I began to establish contact with a power greater than the group through prayer and meditation, reading the literature and trying to the best of my willingness to change the things that I did on a daily basis. Somewhere along the journey my life began to change. My decision making process began to improve. I had a lot of help from the members of the fellowship, but I was also able to receive the message from others outside of the fellowship.

I am still working toward grasping and developing a manner of living which demands rigorous honesty. I must be honest with myself that even after all the time that I have been sober it is vital to remember that it is a Power greater than myself that keeps it happening one day at a time, and the quality of my life is infinitely more sane than it ever was. The process of recovery from a seemingly hopeless state of mind and body is real. It works, it really does!

**She said:** Restore me to sanity? Restore me to sanity! **Restore** me to sanity. Having

consulted my Concise Oxford Dictionary regarding the word "restore," I realized that this step had the audacity to insinuate that I was (or had been) insane. More than that, it assumed that I had once been sane and needed to be returned to that condition. ME!

I'd been managing my life quite nicely, I thought back then (in the four and a half years since I had stopped drinking). And believe me, that was God doing for me what I could not do for myself; removing the obsession to drink. Sure I was smoking a little grass a few times a week, but it was recreational—like someone who drank normally might drink. Not like I drank.

I was (and am) an alcoholic. I had gotten that. I wasn't a 'potoholic'. I didn't have a problem with grass and I had LOTS of evidence (rationalizations) to support that claim.

Just look at all I'd accomplished: I worked part time. I finished my BA degree. I saw my mom-in-law for whom I was part time caregiver through her post-stroke decline and death. I'd arranged the funeral, had an affair, ran my [third (or second if you don't count the one that was annulled)] marriage into the ground in a manner that was horribly shameful and hurtful to people I loved dearly... now, wait. Wait a minute. Maybe that was a little crazy.

That God, the God that had removed my obsession to drink, was a power greater than me was obvious. And I trusted that power. It had helped me when I couldn't *not* drink. And, you know what? That power showed up again and said, "It's time." That was when I walked into the rooms of AA to stay.

If I'm still crazy, I think it's the good kine crazy.

#### Aloha All,

With the first Intergroup Meeting under our belt I feel it is safe to say we are off to an exciting start. As we read the bylaws I feel myself asking once again, "Is this all we do?" Our charter delineates only two objectives; A) To further the AA program in accordance with the Twelve Traditions and B) To maintain a telephone answering service for Kauai AA. If that were so we could meet once a month read the Traditions Checklist (non-Conference) or the 12x12 (Conference), pay the phone bill and go home. But, somehow, I don't think so many of us show up so often to sell ourselves short in what we could accomplish given a little more direction.

With that in mind, I have carefully reviewed the Guidelines for Central Offices and the overall service structure of AA to create an agenda that calls for far more participation than we have attempted in the past panel, or past few panels according to the remembrances of our elder statesmen. I realize that we are a small population, however, that does not forgive the debt we owe to this fellowship. 
